Notice is hereby given pursuant to Section 11(2) of the Municipal Act, S.O. 2001, Chapter 25, as amended, that the Council of the Town of Milton at its meeting to be held in Town Hall, 43 Brown Street, on April 24, 2006 beginning at 7:30 p.m. will consider the adoption of a bylaw(s) authorizing construction and temporary road closure(s) for the following construction project as noted below.

STREET RECONSTRUCTION

WILLIAMS AVENUE (Commercial St. to Parkway Drive)

The temporary closure(s) will be in effect from June 5, 2006 until September 30, 2006. Such a bylaw will allow for periodic restrictions to through traffic. Local access will be maintained throughout the construction.

BRIDGE NO. 59 REPLACEMENT

SIXTH LINE NASSAGAWEYA (Campbellville S.R. to No. 15 S.R.)

**Development comes
to halt due to appeal**

Work at a Main Street property that's slated for a future shopping centre has stopped now that the development is going to the Ontario Municipal Board (OMB).

A decision recently made by the Town's committee of adjustment regarding the land — located at the southwest corner of Main Street and Thompson Road — has been appealed to the board by abutting business Link-Line, according to Town Director of Planning and Development Mel Iovio.

The committee approved minor variances for the property regarding things like building setbacks.

Iovio said the issue for Link-Line is that the loading bays for the new Loblaw's store, which is planned for the

shopping centre, are going to face its property.

He noted it's felt the view of the back of the store could make the Link-Line lands less desirable to resell down the road for commercial development.

Iovio said no actual construction has taken place at the east-end property yet, but the developer did obtain a site alteration permit so it could prepare the lands for development.

While it's been rumoured that work at the site had to stop because an underground stream has been discovered, Iovio said that's not true.

The OMB hearing will start May 29 in Milton Council Chambers. Five days have been set aside for the proceedings.

you be any different?" McGuinty said at the conference.

"It's also a matter of efficiency. Three years is too short. A four-year term is the ideal period of time for a council to forge an agenda, implement it and then seek the people's judgement."

A four-year council term is something the Association of Municipalities

of Ontario (AMO) has asked for.

AMO surveyed its member municipal councils and found that 61 per cent of respondents supported going from a three to four-year term, with 91 per cent wanting to see the change implemented across the province.
