More details released on tragic industrial accident

Police have released the name of a man killed last Friday in an industrial accident in the area of Boston Church and Lawson roads.

Scarborough resident Girma Selassie, 41, was killed at about 9:40 a.m. while operating machinery at a construction site.

An employee of TACC Construction, the

man was operating a piece of machinery known as a sheep's foot roller used to pack down soil.

The company was building a water pond as part of a reservoir system.

Selassie was in the process of packing down soil on the graded embankment of the water pond when the rear tires slipped off the edge, police said.

The equipment began to slide down the embankment and overturned.

Police said the victim, who wasn't wearing a seatbelt, attempted to jump clear of the roller and was struck by the steel framed roll cage of the safety cab that surrounds the driver's seat.

He fell to the ground landing face down and was pinned under the machine with the weight on his back.

He sustained extensive injuries and was pronounced dead at the scene.

The Ontario Ministry of Labour is investigating, as are Halton police.






