to meet the needs of residents."

Mattamy Homes is fronting funds for the program that bumps up construction timelines and will be reimbursed, without interest, in the future when the roads projects would've normally come forward in municipal budgets.

The program is designed to improve transportation corridors in both the east-west and north-south directions and to more evenly distribute traffic over roadways by providing alternate routes for drivers.

Since the aforementioned sections of road aren't yet accessible to local drivers, the construction work will bear little impact on existing traffic.

No immediate impact Election nominations now closed

The race for town council is officially on, and more than two dozen local residents are contending for the spots.

Friday marked the last day nomination papers could be filed for the November 13 municipal election.

Two more candidates threw their hats in the ring on deadline day to run for councillor positions — local volunteer Paul Scherer in Ward 4 and former candidate Rick Matchett in Ward 3.

Matchett ran in the 2003 election and came in 198 votes behind second-

place finisher Jan Mowbray in a fairly competitive Ward 3 race.

The race for the regional chairman seat also heated up Friday now that Halton CAO Brent Marshall has announced he's retiring to run for the top spot. He's going up against Halton MP Gary Carr, Burlington resident Robert Plaschka and Oakville resident Brian Burton. And yesterday, councillor candidate Lieven Gevaert withdrew his name from the Ward 3 contest.

nation closing, several individuals also filed to run for school trustee seats. Local businesswoman and journalist

Donna Danielli is now seeking the Halton District School Board trustee job, going up against incumbent Paul Tate for the job.

Also, Hamilton resident Micheline

Smithville and Claudette Sassou Messan recently filed to run for French public school board trustee, while Mississauga's Marie Gaudet is the only person seeking the local French Catholic school board trustee position.

At the Halton Catholic District School Board, incumbent trustee Rev. David Wilhelm is the only contender.

The lone candidates weren't to be officially acclaimed until after 5 p.m. yesterday, which was the deadline for candidates to withdraw.

At press time, Town Clerk Troy McHarg was in the process of verifying that each candidate meets the necessary qualifications, which include being at least 18 years old, a Canadian citizen, a resident or landowner in Milton, etc.

"There are a number of different reasons why a person could be disqualified," he noted.

Once he's done, an official list of candidates will be posted on the Town's Web site, www.milton.ca.

The number of candidates in each ward is actually down from the 2003 election, when Wards 1, 2 and 4 each had seven contenders. Last time, Krantz had five challengers looking to unseat him from the position he's now held for 26 years.

This year also marks the first time since 1997 that Barry Lee hasn't been acclaimed for the Wards 1 and 3 local and regional councillor spot.
