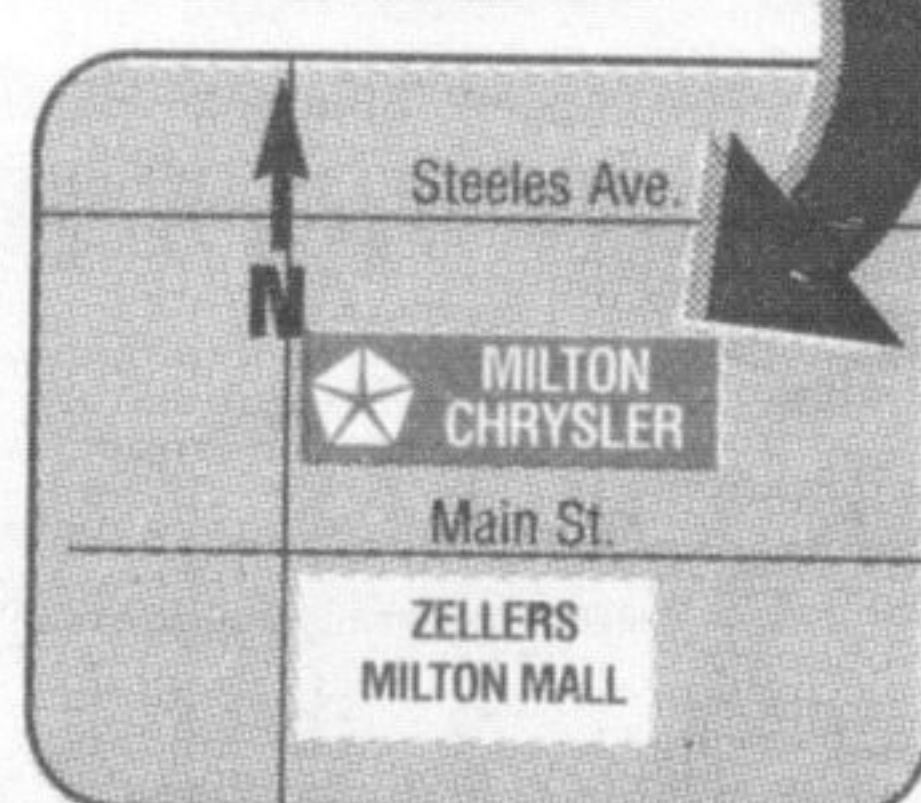

## Mortgage fraud case is in court

A pre-trial for a Milton couple facing numerous charges in connection with a series of mortgage frauds will continue this week.

The pre-trial — which is a meeting held to hammer out legal issues before trial — will take place at Superior Court of Justice in Newmarket Thursday. The return date was set August 24.

Frank Basso and his wife, Catherine, were charged with a total of 16 and 10 counts respectively of fraud over \$5,000, conspiracy to commit fraud, uttering a forged document, obtaining money by a forged document and obtaining credit by false pretence along with three other non-Milton residents.

The charges relate to two incidents in 2001 and 2002 in which fraudulent mortgages were arranged on houses unbeknownst to the owners — relatives of the suspects — to obtain money.

York Regional Police allege \$1.7 million was pocketed by the five suspects from a total of three incidents in Toronto and Vaughan, one in which no charges were laid against the Milton couple.
