# RIDE checks nab more drinking drivers, but fewer vehicles stopped by police

The recent holiday RIDE place last month, saw 27,359 program revealed somewhat disappointing results, with more drivers operating their vehicles after consuming alcohol than in the previous year.

This comes despite the fact fewer vehicles were checked, reported Halton Regional Police.





# Hamilton man charged in quick change scam

#### Second suspect remains at large

A man has been charged in connection with a quick change scam that saw north Halton businesses targeted last

On February 28, two men showed up at the Speyside Gas and Convenience store on Regional Road 25. One man approached a cashier and purchased a low-priced item and paid for it with a large bill, police said.

While the second man distracted other people from what was happening, the first man asked the cashier to change some larger bills for smaller bills, police said.

He then kept changing his mind as to what denominations he wanted until the cashier was confused as to how much he owed the suspect and he handed over too much.

The two men then left the store with about \$400 more than when they entered, police said.

Three Halton Hills-area businesses were targeted with the same scam the following month.

Two of the four incidents were recorded on surveillance cameras, and still photos were obtained.

After a lengthy investigation, police were able to identify one of the two sus-

Police allege the same suspect was connected with numerous similar incidents across Ontario, and charges are pending in other jurisdictions.

An arrest was made January 9.

A 39-year-old Hamilton man has been charged with four counts each of theft under \$5,000 and fraud under \$5,000.

The second suspect remains unidentified.






