### TAX NOTICE

Ratepayers of the Town of Milton are reminded that the 1st installment of the 2007 Interim Tax Bill is due on Wednesday, February 28, 2007.

If you require information about taxes, please contact the Corporate Services, Tax Division at (905) 878-7252 ext. 2193, 8:30a.m. to 4:30 p.m. Monday to Friday.

Tax payments must be received in the Corporate Services Office on or before the due date to avoid penalty. A late payment charge of 1.25% will be charged on the first day of default and on the first day of each calendar month in which the default continues.

It is the responsibility of the ratepayer to ensure that the taxes are paid by the due date, even in the event that the bill is not received as mailed.

**Taxes may be paid:**

- a) By mail: Corporate Services, Tax Division, 43 Brown St., Milton On. L9T 5H2 **Cheques post-dated to the due date are accepted and encouraged.**
- b) Telephone or Internet banking (check with your financial institution for details)
- c) By using the mail deposit box to the left of the glass doors at Town Hall (all hours)
- d) Between the hours of 8:30 a.m. and 4:30 p.m. at the Corporate Services (Tax Division), Town Hall, 43 Brown St., Milton. (Cheque or money order is preferred, rather than cash). Direct Debit also accepted.
- e) Please contact our office for details regarding the Pre-Authorized Tax Payment Program.
