Snobelen back in court Mon.

Milton resident and former Ontario cabinet minister John Snobelen will return to court Monday.

Snobelen, 52, has been charged with careless storage of a firearm, unauthorized possession of a firearm and unlawful

acquisition of a firearm.

The date was set March 19 at Ontario Court of Justice in Milton.

The charges stem from a search at a Milton house January 9 when Halton Regional Police allegedly seized a Colt .22-calibre semi-automatic pistol and ammunition.

Three days later, Snobelen turned himself in to police and was later released.

Snobelen served as minister of education from 1995 to 1997. He was also a Mississauga MPP.
