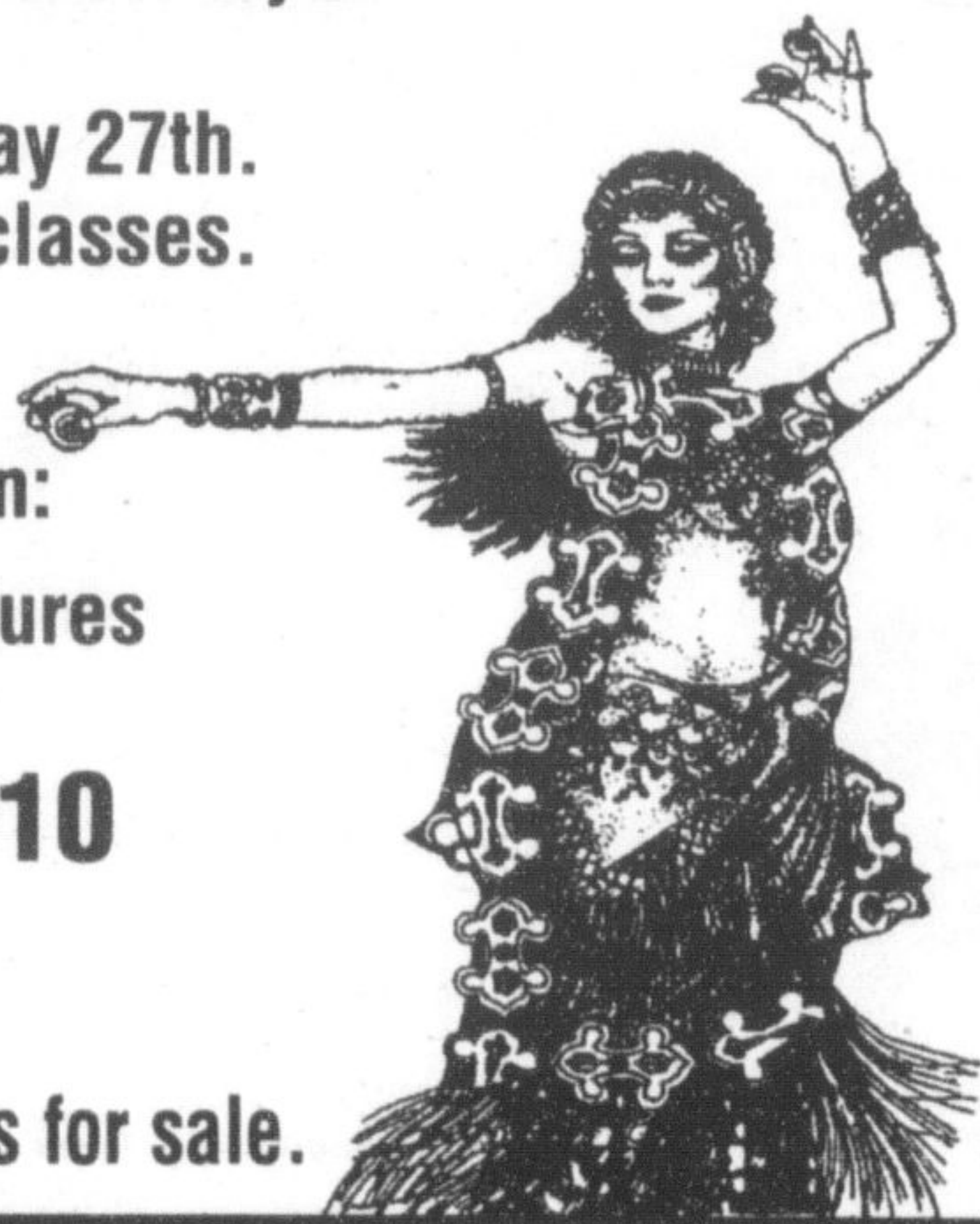

NOTICE OF APPLICATION AND NOTICE OF WRITTEN HEARING AS FRANCHISE FOR THE CORPORATION OF THE TOWN OF MILTON

Union Gas Limited (the "Applicant") has filed an application dated March 15, 2007 with the Ontario Energy Board (the "Board") under the Municipal Franchises Act, R.S.O. 1990, c. M.55 for an order of the Board approving the terms and conditions upon which and the period for which the Corporation of the Town of Milton is, by by-law to grant to the Applicant the right to construct and operate works for the distribution of gas, and the right to extend and add to the works in the Town of Milton.

The Applicant has also applied for an order of the Board declaring and directing that the assent of the electors of the Town of Milton to the by-law is not necessary. The Board has assigned file number EB-2007-0094 to the application. The Applicant is presently serving the Corporation under the authority of a Certificate of Public Convenience and Necessity (F.B.C. 42, F.B.C. 43 and F.B.C. 324), and has a franchise agreement, (E.B.A. 225), which expires on November 7, 2007.

The application will be decided by the Manager, Facilities Applications, who has been delegated this authority pursuant to section 6 of the Ontario Energy Board Act, 1998, S.O. 1998, c.15 (Schedule B). The Manager, Facilities Applications does not intend to provide for an award of costs when deciding this application.

Copies of the application are available for inspection at the Board's office, the Applicant's head office, the Applicant's regional office and the office of the Corporation of the Town of Milton, at the addresses indicated below.

The Board intends to proceed with the application by way of a written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. If you object to the Board holding a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board within 7 days of the publication date of this Notice.

If you wish to participate in the written hearing, you must forward three copies of your written submissions to the Assistant Secretary of the Board and one copy to the applicant at the addresses below. All submissions must be received no later than 14 days after the publication date of this Notice. If the Applicant wishes to respond to the written submissions, such response must be received by the Board no later than 21 days after the publication date of this Notice. All submissions must quote file no. EB-2007-0094, clearly state the sender's name and address, and be received by the Board Secretary by 4:45 p.m. on the required dates.

IF YOU DO NOT FILE A WRITTEN SUBMISSION OBJECTING TO A WRITTEN HEARING OR DO NOT PARTICIPATE IN THE HEARING BY FILING WRITTEN SUBMISSIONS IN ACCORDANCE WITH THIS NOTICE, THE BOARD MAY PROCEED WITHOUT YOUR PARTICIPATION AND YOU WILL NOT BE ENTITLED TO FURTHER NOTICE IN THIS PROCEEDING.

ECHL rookie seeing fair amount of playing time

While Konkle hasn't exactly been on fire since what head coach Jason Fitzsimmons described as his coming out party, he has recorded an assist in three of the last four games to help aid the 34-24-4-5 Stingrays' ongoing play-off bid. And the eight goals and 13 helpers he has overall this season — in 50 games — is far from shabby for an ECHL rookie.

"Right away this season I was playing on the top line and getting a lot of powerplay time. And recently I've been used in some shoot-outs," noted Konkle. "Coach Fitzsimmons says he likes what he sees from me offensively, and that's been a big confidence booster."

And the fact that South Carolina remains in the post-season hunt with just a handful of games remaining — including last night's trip to Gwinnett — makes this spring more enjoyable.

"Sure I had more personal success last year, but it doesn't mean as much when a team's going nowhere," he recalled of a 2005/06 campaign with Elmira that ended with a disappointing 27-42-7 record — and no playoff berth.

"Individual production is great, but the important thing is that you're winning."

The Stingrays will have to do some more of that over the next eight days, as heading into last night they sat in a three-way tie for the fourth and final playoff spot in the ECHL's South Division.

Meanwhile, Milton's other full-time ECHL — Trenton Titans captain Scott Bertoli — is now back among the league's top scorers, sitting tied for 14th place with 25 goals and 44 assists in 59 games.

The 30-year-old's Titans sit fourth in the North at 33-29-1-4.

With his suitcases receiving as much of a workout as he has this season, fellow Miltonian Jon Glead has been bouncing between the American Hockey League's Hamilton Bulldogs and the ECHL's Cincinnati Cyclones.

The 23-year-old defenceman has three goals and six assists with Cincinnati, with the latest helper coming in Tuesday's 3-1 loss to Johnstown — less than 24 hours after his latest reassignment.

Assuming he sticks with the Cyclones for the remainder of the season, Glead is the only local player pretty much guaranteed to see playoff action right now — with Cincinnati currently second in the North at 35-26-3-2 and needing just one more win to solidify post-season entry.

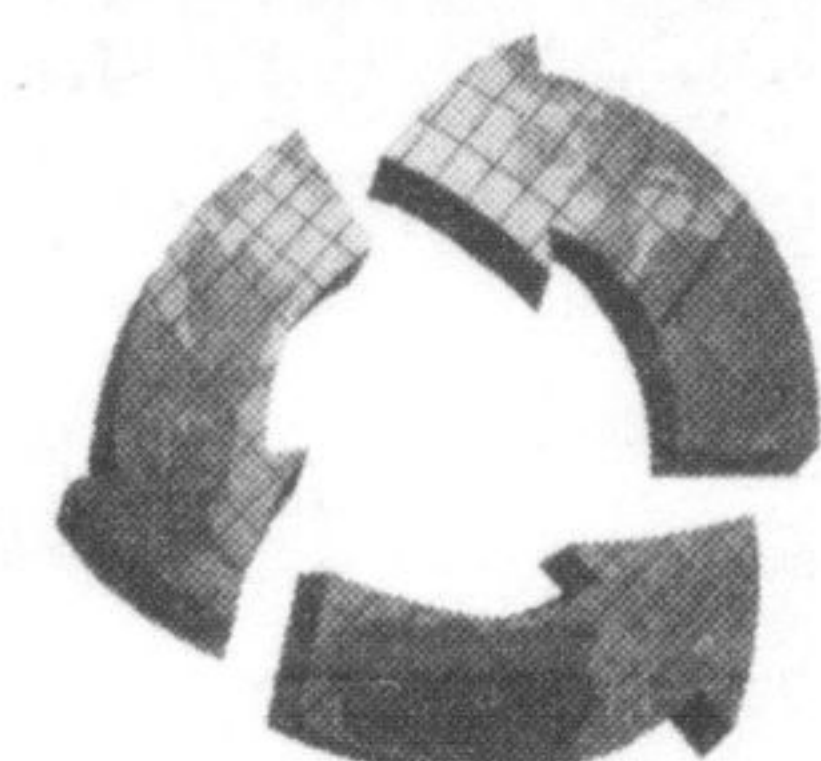
