An investigation by the Ministry of Labour found the worker didn't have previous experience using a lift truck and that Exel hadn't investigated the employee's references to ensure the worker had the neces-

sary experience before being assigned to operate the truck.

Exel Canada Ltd., located on Parkhill Drive, pleaded guilty to failing to take the reasonable precaution of checking the qualifications of the worker to operate a lift truck.
