

## Renaming rural road a bad idea

(The following letter was addressed to the Town of Milton, and a copy was filed with the Champion.)

#### **DEAR TOWN OF MILTON:**

This correspondence is in regard to your plan to re-name No. 3 Sideroad.

I'm against this proposal for the inconvenience factor alone. No. 3 Sideroad has existed for many years — at least two decades — and I feel that to change the name would cause more confusion than it would solve. I know for a fact that the police, fire department and ambulance service all know where it is, and can arrive on site in a good time frame. .

However, if the decision is made to change both the name and residence numbering on No. 3 Sideroad, my concern is the cost factor. Who will bear the cost of this decision?

I'm looking at contacting sev-

eral ministries to update my address, contacting my bank, insurance companies, lawyer and accountant, etc., not to mention the labour of phoning or sending change of address cards to all my friends and family, of which several are out of town, out of

province and out of country. Who will pay for these numerous change of address cards, postage, faxes, mailing supplies, long distance calls, and, most importantly, my time away from work to accomplish these deeds. Certainly not myself!

Several residents of No. 3 Sideroad are elderly, retired people, some of whom English is not their native tongue. Who will assist them to contact the necessary ministries to change their pension information, as well as any other documents and, if needed, take them to the required ministries to perform the changes? If I am not mistaken, with all the health card fraud that is around, the Ministry of Health requires you to make any changes and renewals in person.

These pensioners can not, given their income, bear the additional costs required for such an endeavour.

I have read in several newspapers and seen on TV news reports that Milton has the highest rate of population increase in Canada. I feel that it would be in the best interest of the residents of Milton if town council were to direct their resources to improving other aspects of the town, as opposed to re-naming an already established and existing road.

I feel that town council should concern itself with naming the new streets, as well as planning them, that will be created during the town's expansion with the new houses being built.

As a percentage, volcanoes contribute only 0.75 per cent of the total CO2 when compared to human activity and therefore are not the major generator, as stated by Walker.
