Drunk driving suspect granted bail again

An accused drunk driver involved in the death of a motorist last February has been granted bail again after he was arrested for allegedly violating one of his bail conditions.

Alvaro Diaz, 21, had been in custody for six days following his arrest in Burlington Thursday, Sept. 6 by Halton police who charged him with breach of recognizance of bail and possession of a controlled substance.

Police allege Diaz violated one of his release conditions — that he not sit in the front passenger seat of a vehicle. He was also charged with being in possession of marijuana.

He's been out on bail since February when the original charges were laid.

In the early morning hours of February 2, Diaz was driving northbound on Regional Road 25 near No. 5 Sideroad when he collided with a vehicle being driven by a 48-year-old Orangeville man, who was later pronounced dead.

Diaz was charged with impaired driving causing death, dangerous driving causing death and having over the legal limit of alcohol in his blood.

He was also charged with driving with alcohol above zero with a G2 licence and using unauthorized licence plates.

At Wednesday's bail hearing at Ontario Court of Justice in Milton, Diaz was released into the custody of his parents, who offered to continue to serve as his sureties.

Diaz's parents put up \$30,000 to the court in collateral to secure his release.

The conditions imposed by Justice of the Peace Denis Lee include that Diaz, formerly of Milton, reside with his mother, Carolina, and 13-year-old brother at their new home in Burlington.

The court ordered that Diaz must be at home between 9 p.m. and 6 a.m.,

except for medical emergencies, employment, or if he's with one of his parents.

He can't sit in the front seat of any vehicle, must be driven to and from school and work by one of his parents and must report to Burlington police weekly.

Diaz was ordered not to have any communication with three friends, including the registered owner of the car in which he allegedly sat in the front seat.

He was also prohibited from purchasing and consuming any alcohol or drugs.

Diaz appeared unemotional as he stood handcuffed in the prisoner's box while his lawyer, Mary Cremer, argued for bail.

His sloppy apparel — a baggy, sleeveless shirt and jean shorts — was in sharp contrast to the smart business casual outfit he sported at a court appearance last week.

Proceedings emotional

At one point in the proceedings, Diaz's father, Ivan, broke down on the stand, sobbing. The court took a short recess before Crown attorney Brian O'Marra continued questioning him.

The younger Diaz remained poker-faced even when Lee rendered his decision.

His parents, aunt and another supporter, on the other hand, gave a visible sigh of relief.

Diaz is one of three Milton residents charged with drunk driving in the deaths of four victims this year.

He'll make his next court appearance Tuesday, Sept. 25 in Milton to set a pre-trial date.

A preliminary hearing has been set for April 2 and 4, 2008.

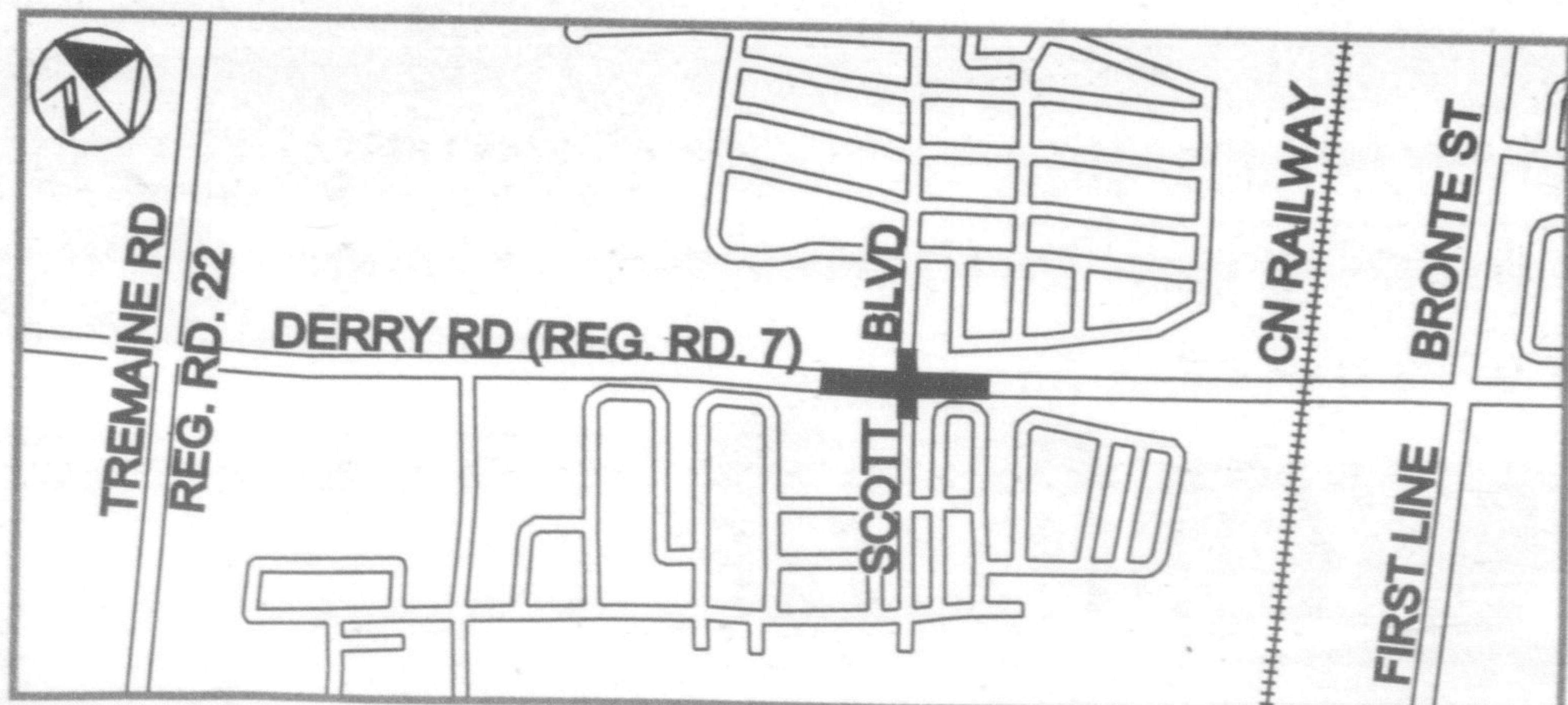

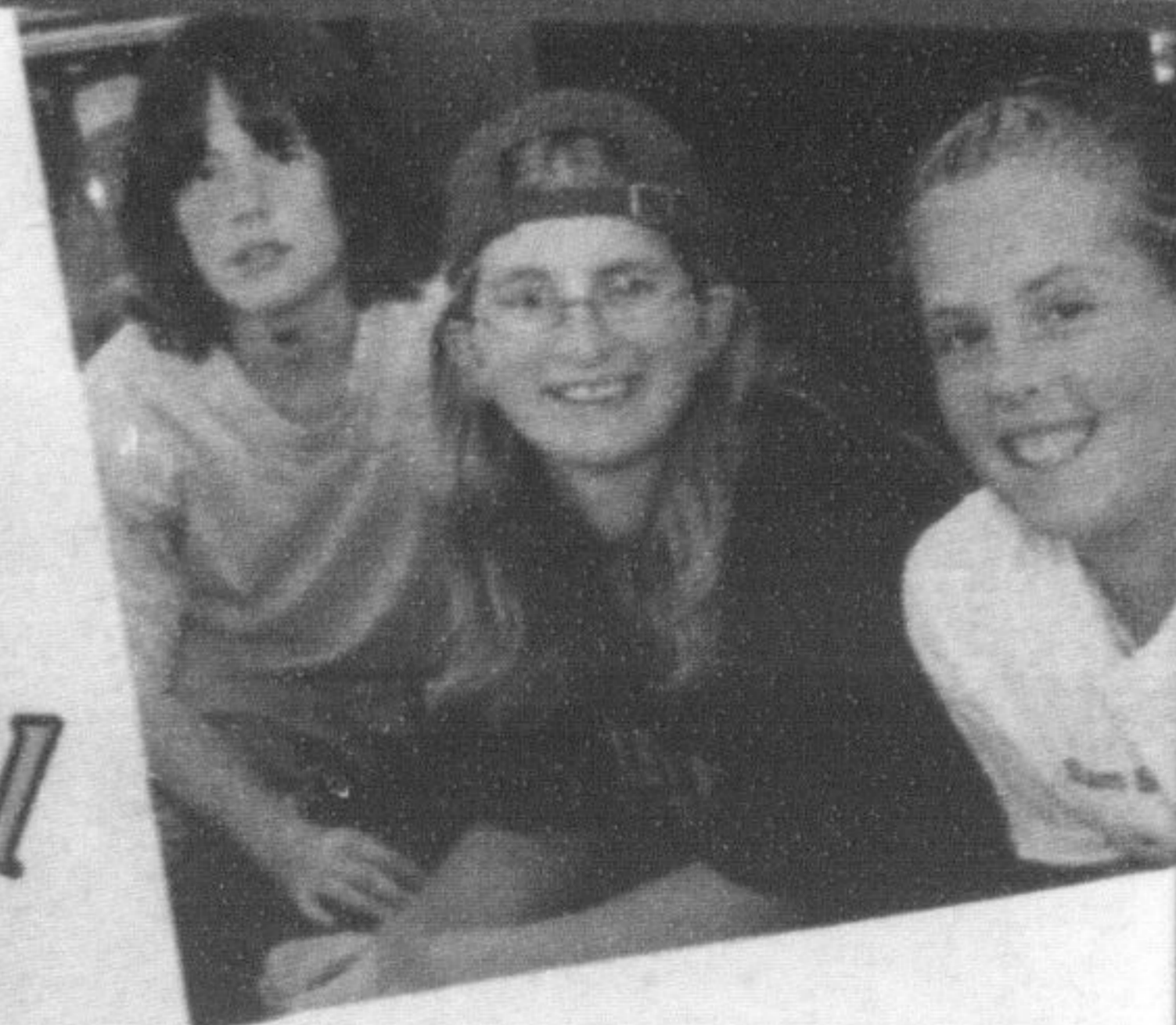
