No more Band-Aid solutions. The Province needs a serious issue of general praccomprehensive plan to ensure Ontario residents have access to a family physician.

A lengthy investigation by Metroland West Media Group (see Part 2 inside today's Champion) reveals the Province is spending less money and allocating fewer resources on programs designed to find and keep family doctors here.

"Forecasting the current or future need for any health profession is very difficult," the Ministry of Health said in answer to questions posed by Metroland.

The GTA — in particular Halton — is experiencing unprecedented growth. The shortage of doctors and the titioners not wanting to work in hospitals are among the many problems plaguing the health-care system.

Halton Region had the foresight to hire a full-time family physician co-ordinator. It is Angela Sugden Praysner's job to entice general practitioners to set up shop in Halton's four municipalities. Over the past five years, she has recruited 60 doctors. While that number sounds impressive, the area still requires 30 doctors.
