

# Volunteers sought for St. John Ambulance

The local branch of St. John Ambulance is in urgent need of more volunteers.

With the population increasing quickly, the organization finds itself with an insufficient number of volunteers to help it grow with the community, said Hazel Blundell, a volunteer board member with the Oakville/Halton Hills/Milton administration centre.

"We also have no specific volunteers or groups in Milton," she added, noting St. John Ambulance does provide volunteer coverage at several activities in

Milton with its Halton Hills group.

Currently the local branch is seeking volunteers for the following programs:

- Therapy dog services — volunteers and dogs visit the elderly and sick
- Youth leadership — a leadership program for children ages eight to 16 that teaches first aid and community stewardship
- Medical responder — adult volunteers who provide mobile first response at events such as parades and farmers' markets
- Car seat safety team — help par-

ents with the appropriate choice and installation of child safety seats

• Fundraising — to help support the expansion and development of the aforementioned activities

"I feel the programs offer the individuals a variety of ways to help in their immediate community and provide both personal and sometimes career development," said Blundell. "The benefit to our community is a caring, safer place to live."

### DEVELOPMENT CHARGES ACT, 1997 S.O. 1997, c. 27

#### NOTICE OF THE PASSING OF BY-LAW NO. 62-08, BEING A BY-LAW TO ESTABLISH WATER, WASTEWATER, ROADS AND GENERAL SERVICES DEVELOPMENT CHARGES FOR THE REGIONAL MUNICIPALITY OF HALTON (HUSP/NON-HUSP) AND TO REPEAL DEVELOPMENT CHARGES BY-LAW NOS. 102-03, 57-04 and 99-04 AS AMENDED AND TO REPEAL BY-LAW NO. 100-04.

TAKE NOTICE that the Council of The Regional Municipality of Halton passed By-law No. 62-08 on the 28th of May, 2008 under the *Development Charges Act, 1997* (the "Act") which establishes water, wastewater, roads and general services development charges for the Regional Municipality of Halton (HUSP/Non-HUSP), and repeals By-law Nos. 102-03, 57-04 and 99-04 as amended and repeals By-law No. 100-04.

This By-law No. 62-08 comes into force on the 18th day of August, 2008.

AND TAKE NOTICE that any person or organization may appeal this By-law to the Ontario Municipal Board under section 14 of the Act by filing with **the Clerk of The Regional Municipality of Halton, 1151 Bronte Road, Oakville, Ontario, L6M 3L1 / fax: 905-825-8838** not later than 4:30 p.m. on the **7th day of July, 2008**, a written notice of appeal setting out the objection to the By-law and the reasons supporting the objection.

The complete By-law is available for examination at the Clerk's office 1151 Bronte Road, Oakville, Ontario, L6M 3L1 during regular office hours, 8:30 a.m. to 4:30 p.m., Monday to Friday. An explanation of the development charges imposed and a description of the lands to which the By-law applies are set out below.

#### OVERVIEW

By-law No. 62-08 establishes updated area specific (HUSP/Non-HUSP) water and wastewater development charges and region-wide roads and general services (being growth studies, police, emergency medical services, services for seniors, facilities and social housing) development charges and repeals By-law Nos. 102-03, 54-07 and 99-04 as amended and By-law No. 100-04.

The HUSP Urban and Rural Residential Development Charges are shown on Schedule "B-1" of the By-law, the Non-HUSP Urban and Rural Residential Development Charges are shown on Schedule "B-2" of the By-law, the HUSP Urban and Rural Non-Residential Development Charges are shown on Schedule "C-1" of the By-law, and the Non-HUSP Urban and Rural Non-Residential Development Charges are shown on Schedule "C-2" of the By-law, all of which are attached to this notice.

#### LANDS AFFECTED

This By-law applies to all lands in the geographic area of the Regional Municipality of Halton. A key map, being Schedule "A" of the By-law, is attached.

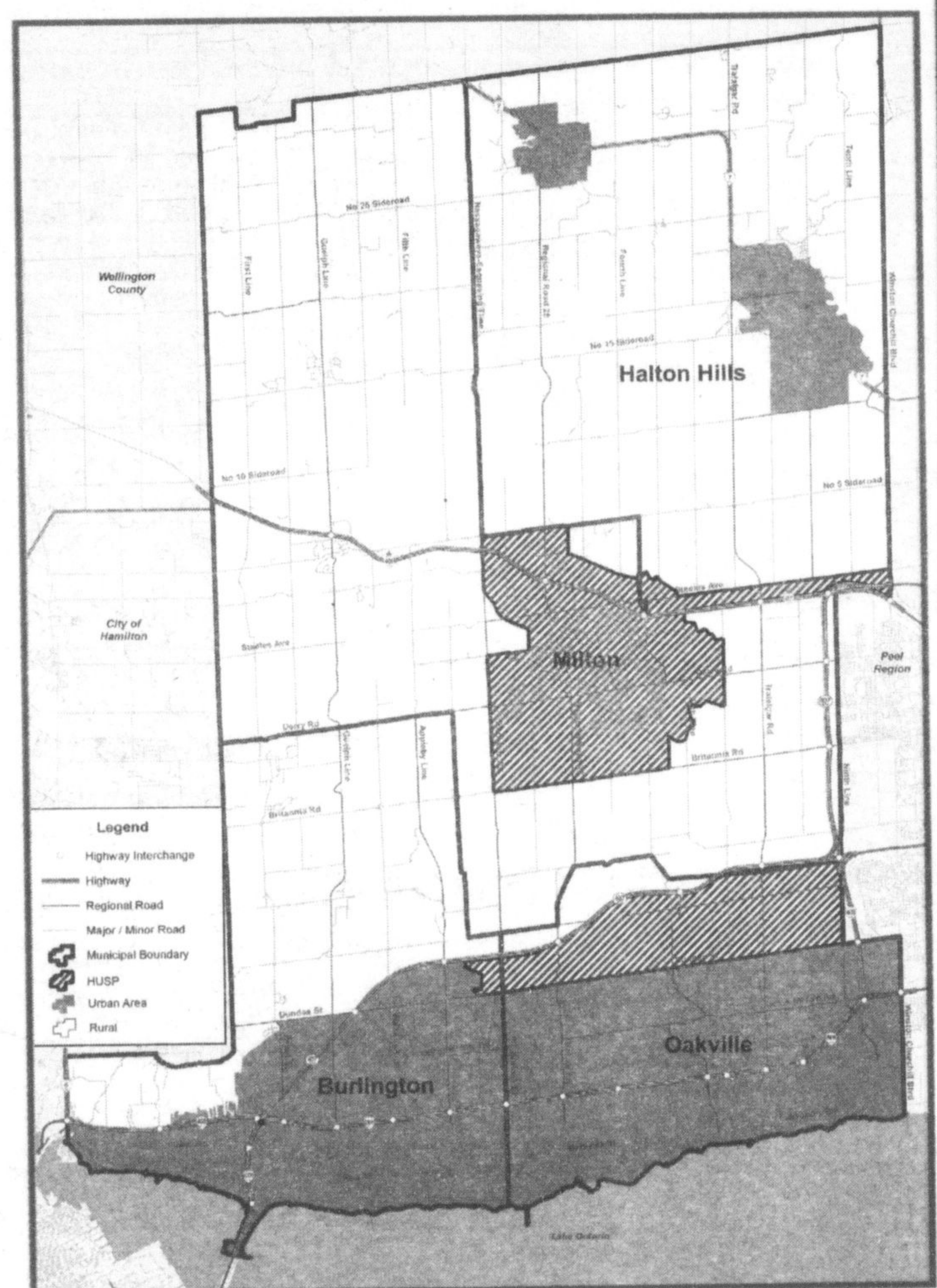
The development of land in the Region may be subject to one or more development charge by-laws of the Region.
