

Big move to new Town Hall to start in late Nov.

The Town will officially be getting the keys to the Town Hall expansion November 21.

The date was presented to Milton council at its meeting last week in an update report on the 50,000-square-foot, two-storey addition to the historic downtown building.

Following November 21, Town staff will be moved in phases from their temporary location on Industrial Drive to the new Town Hall, said Director of Community Services Jennifer Reynolds.

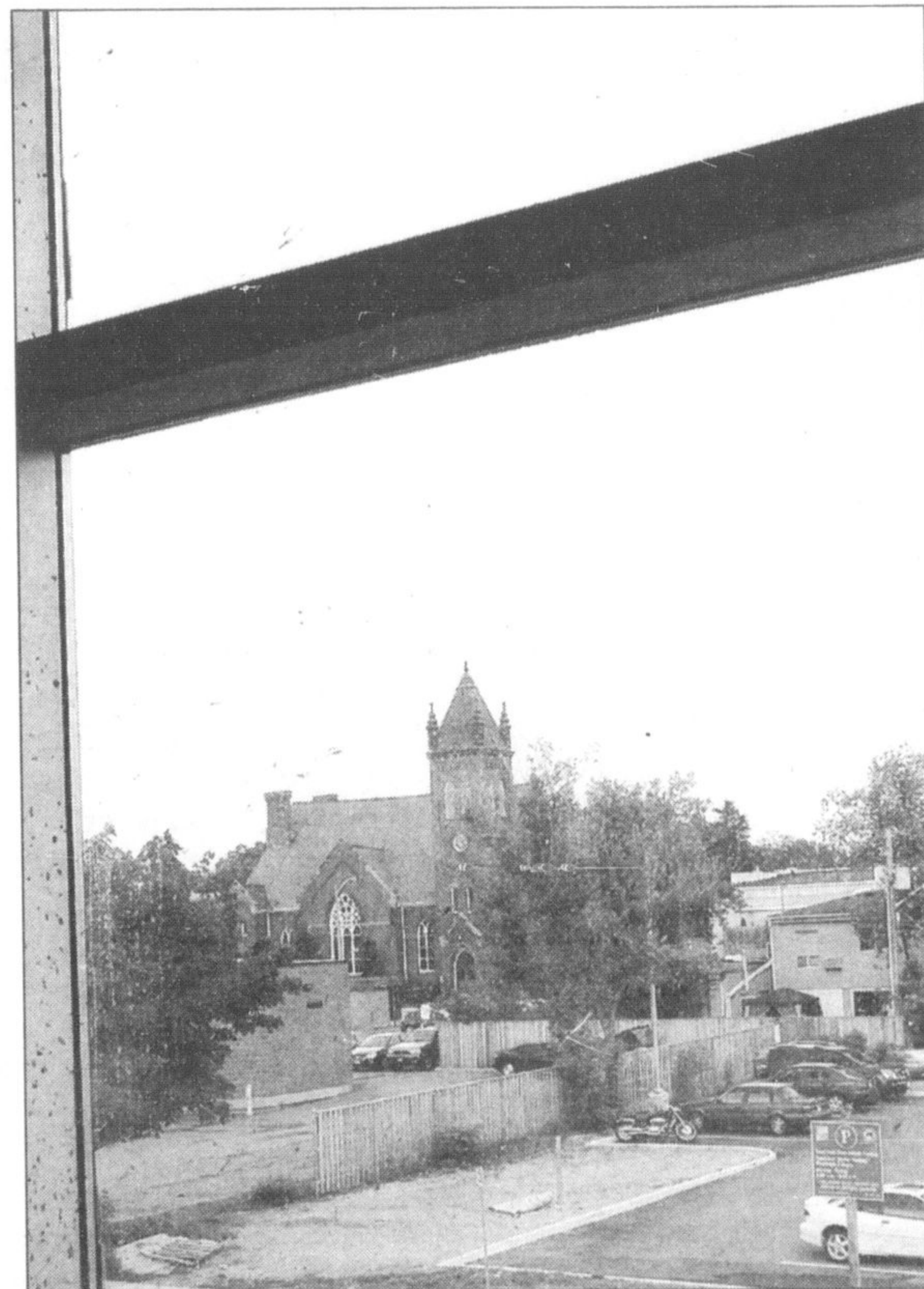
Renovation of the existing Town Hall will kick off in early December and be completed by late February 2009, the report to council indicates.

The report also detailed other progress on the \$24.2-million expansion, such as that:

- Exterior stone cladding is nearing completion
- The roof and exterior enclosure are complete
- Site services utility work will commence within the next month and be finished in September
- Leadership in Energy and Environmental Design (LEED) documentation of the project is ongoing, with a target to obtain a minimum LEED 'basic' certification

The Mary Street West parking lot landscape plan and improvements to Hugh Lane have been approved by the Town Hall steering committee and are currently being prepared for tender

Special designation sought to allow core development

Floodplain prevents growth in downtown

The Town is looking to pursue a provincial designation for the downtown that would allow growth to continue, even though the area falls within a floodplain.

At its meeting last week, town council directed staff to seek a Special Policy Area (SPA) designation for the core, subject to the projected \$60,000 cost of a needed study being shared between the Town, landowners, Conservation Halton (CH) and the Region.

While new development typically isn't allowed in a floodplain, an interim SPA designation was put on the downtown about 20 years ago to permit some development.

But the SPA was never approved as a permanent one by the Province.

CH was initially going to remove the interim policy, but has agreed to hold off while the Town pursues a permanent designation — a process that can take years.

Without the SPA, large-scale redevelopment and multi-lot development would be limited in the downtown.

In addition to pursuing the designation, the Town is also going to investigate flood-proofing measures for the

downtown.

Staff will report back to council on the funding sources for the SPA study.
