

Thieves ransack home; about \$1,500 in property stolen

Police are looking for two vehicles in connection with a break-in on Marshall Crescent Monday afternoon.

Sometime between 1:30 and 4:15 p.m., unknown suspects gained entry to the home by forcing open the garage door. Once inside, they took a plasma TV and speakers, among other items.

The value of the stolen property is estimated at \$1,500.

Neighbours report seeing a white van and white Eagle Talon circling the area shortly before the break-in.

Boy charged with assault

A domestic incident involving a youth and his parents has resulted in a number of charges.

Following the Tuesday evening altercation, a 15-year-old Milton boy has been charged with two counts of assault with a dangerous weapon, possession of a dangerous weapon and uttering threats.

Mischief charge for youth

A boy faces charges following an incident of mischief at Luxton Park in Hawthorne Village Sunday night.

At about 11 p.m. police received a report of youths smashing beer bottles in the park's gazebo.

A 16-year-old Milton boy was charged with mischief and breach of probation.

Impaired driving charges laid

A single-vehicle accident earlier this week has led to charges against a 37-year-old

A 2007 Ford van — grey with orange stripes, Peatson's Heating written on the side and a licence plate of A71 4KT — were removed from a Trudeau Drive residence sometime between 4 and 9:30 a.m. Sunday.

A number of power tools were inside the

van, while an iPod and martial arts gear was taken from another vehicle in the driveway.

There was no value estimate available on the stolen van and property.

A 2000 Honda Civic — beige, with a licence plate of 140 VSV — was stolen from a residence on Childs Drive overnight Saturday. It's valued at about \$8,000.

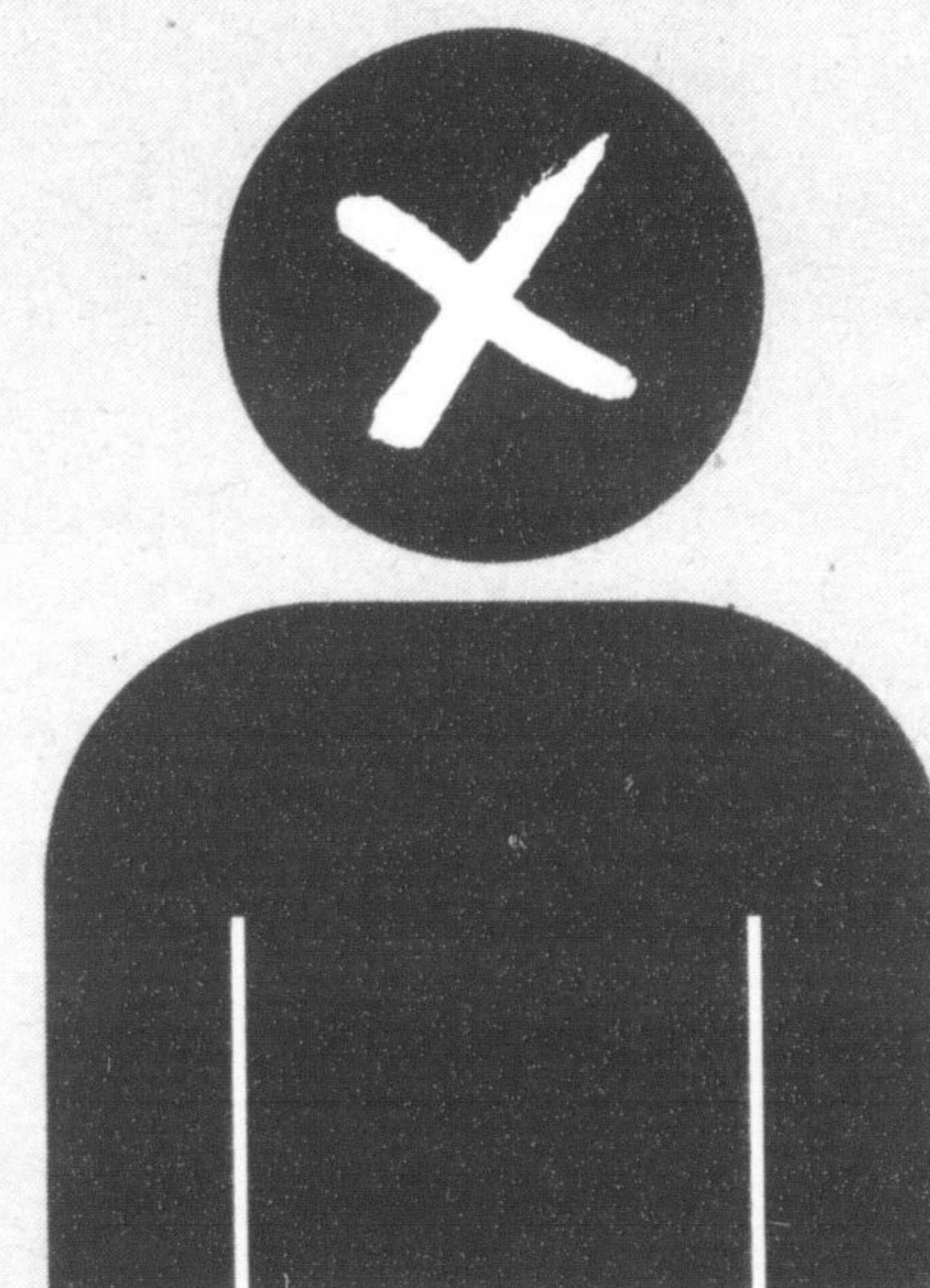

New identification rules to vote!

WHEN YOU VOTE, YOU MUST PROVE YOUR IDENTITY AND ADDRESS.



YOU HAVE THREE OPTIONS:

Provide **one original piece of identification** issued by a government or government agency containing your photo, name and address.
e.g.: driver's licence

OR

Provide **two original pieces of identification** authorized by the Chief Electoral Officer of Canada. **Both pieces must contain your name and one must also contain your address.**
e.g.: health card and hydro bill

OR

Swear an oath and be vouched for by an elector who is on the list of electors in the same polling division and who has an acceptable piece or pieces of identification.
e.g.: a neighbour, your roommate

- Letter from public curator

Note: The pieces of identification required under the Canada Elections Act are not the same as those for provincial or municipal elections. The above information is also available in a number of heritage and Aboriginal languages on the Elections Canada Web site at www.elections.ca.
