Smith said it's only recently that he's come to know the Lambert family — Lisa and Pat and their children, Christopher and sevenyear-old Ryan — but already he's been struck by how close-knit they are and their positive attitudes.

"They're so down to earth, such amazing people, and you see how much effort they put into everything," he said, adding it was easy to get excited about the fundraiser.

Christopher was diagnosed with cerebral palsy at the age of nine months.

He has limited use of his arms, his eyesight is damaged and he can't feed himself or grab hold of objects. He also can't operate his wheelchair on his own, and can speak only a few words.

But, said his mom, his smile can light up a room. He also has a high level of comprehension and is very social.

Lisa said she can't believe how much effort Smith and his friends are putting into this event.

"I haven't met anyone quite like him — to want to do all that to help out," she said.

"I'm quite overwhelmed by the whole thing."

It's an amazing group of friends that has devoted their time to this fundraiser. Although they've each gone their separate ways - Smith actually lives out of the country and is just home for the holidays — a group of about 70 friends remain close and keep in contact, often seeking out charity opportunities.

Two years ago, the group travelled to Chicago to participate in the "Embrace Race," where they broke the record for giving the most hugs in 24 hours.

Three local bands will rock the house for charity at Hardball Café next weekend.


Classic rock group Traffic, Foo Fighters tribute band In Your Honor and prominent local ensemble The Randalls will hit the stage Saturday, December 20.
