

Microchip clinic tomorrow

The Town of Milton will host a microchip clinic for household pets in partnership with the Oakville and District Humane Society.

The event tomorrow will enable owners of dogs, which are required by the Town to be licensed, to avoid annual licensing costs by getting their pet microchipped and purchasing a microchipped tag valid for the life of the dog.

By directly injecting microchips into an animal, it makes it easier for lost pets to be tracked, even outside the municipality. The process is quick and relatively painless, states the Town.

Cats do not require a license or microchip

but they must have a collar with a permanent inscription of the owner's name and address.

The cost of the microchip implant is \$29.95. Annual and lifetime dog tags will also be available at the clinic. For a full listing of dog tags and corresponding prices, visit www.milton.ca and click on Dog Tags in the Site Index.

The microchip clinic will take place from 10 a.m. to 3 p.m. at the Milton Seniors' Activity Centre, 500 Childs Dr.

Owners must ensure their pets are in a carrier or on a leash and under the control of a person with sufficient strength to maintain control of the animal.

Notice of Filing of Addendum

Class Environmental Assessment for North Oakville Wastewater (Sewage) Pumping Station

In 2008, Halton Region completed the South Halton Water and Wastewater Master Plan Update Class Environmental Assessment (Class EA) Study. The Master Plan Update (MPU) identified a preferred servicing strategy to accommodate growth to the year 2021 in the southern area of the Region, including a need for a new wastewater pumping station on Neyagawa Boulevard, north of Dundas Street to service the North Oakville East Community.

Subsequent to finalizing the MPU document, the North Oakville East Secondary Plan Area Servicing Study has identified alternative sites for the location of the pumping station. In response to the availability of this new information, Halton Region staff have completed an Addendum to the 2008 South Halton Water and Wastewater MPU Class EA Study for the North Oakville Sewage Pumping Station, documenting the basis for the changes and the revised recommendations.

This Notice of the Addendum is being placed on the public record for review in accordance with the requirement of the Municipal Class Environmental Assessment process. Subject to comments received as a result of this Notice and the receipt of all necessary approvals, Halton Region intends to proceed with the detailed design and construction as documented in the Addendum.

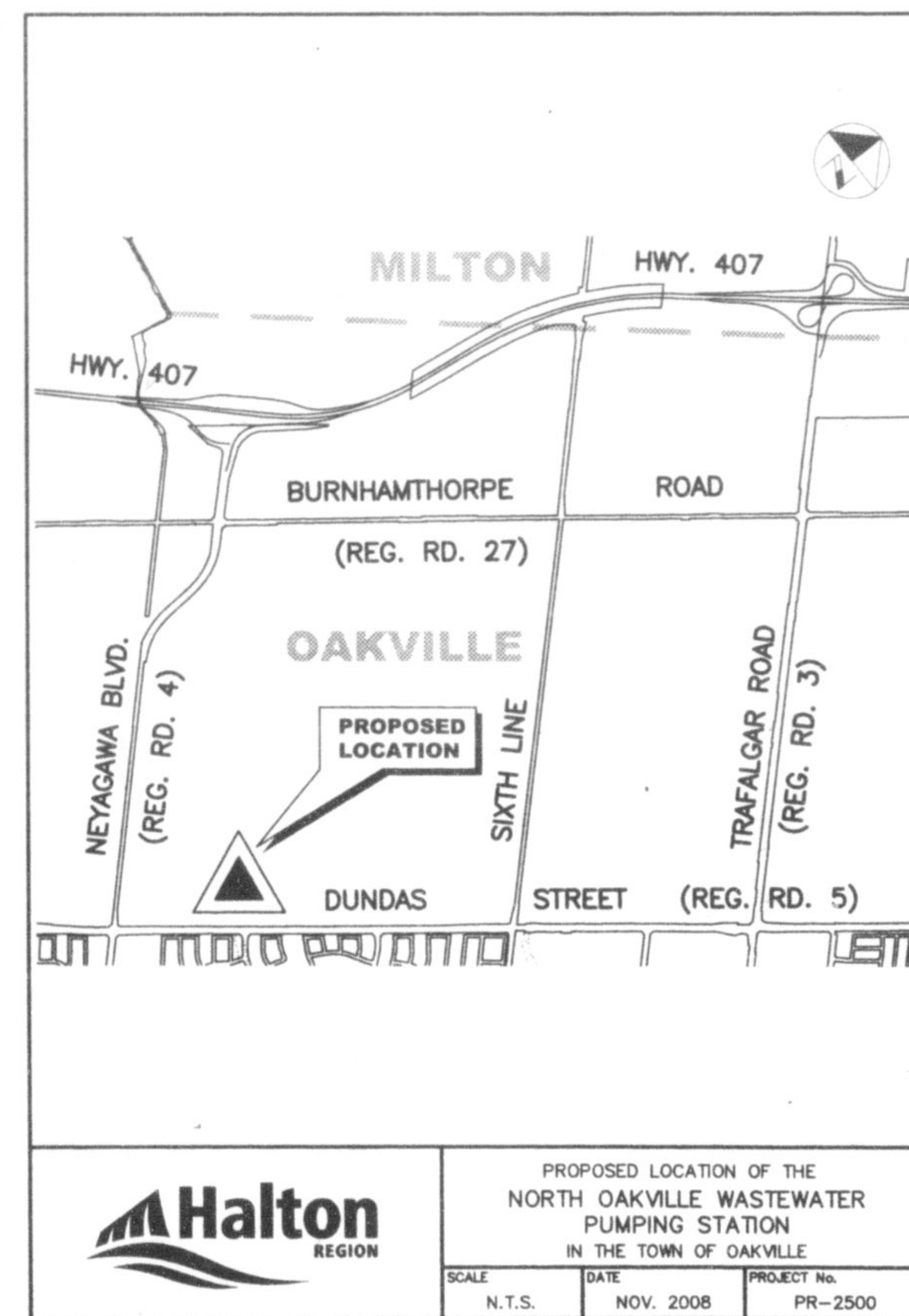
The Addendum Report will be available for a review period starting on **March 30, 2009 until April 28, 2009**, at the following locations:

If concerns arise during the prescribed Review Period that cannot be resolved through discussions with Halton Region, a person or party may request that the Minister of Environment make an order for the project to comply with Part II of the Environmental Assessment Act. This request (commonly referred to as a Part II Order) must be received within the above prescribed 30 calendar day review period by the Minister, at the address listed below and copied to Mr Mickey Liu at Halton Region. If no request is received on or before April 28, 2009, the Region may proceed with detailed design and construction of the project.
