### NOTICE OF PUBLIC OPEN HOUSE / PUBLIC WORKSHOP REGARDING THE TOWN OF MILTON INTENSIFICATION / INFILL STUDY

The Town of Milton is undertaking an Intensification / Infill Study for its Urban Growth Centre and Built Boundary Area. The purpose of the study is to establish a more detailed planning framework for the Town's provincially designated Urban Growth Centre and its designated Built Boundary. The Province of Ontario requires that intensification takes place within these areas and the purpose of the Intensification / Infill Study is to determine the most appropriate locations for this to take place. The study will also look at the associated urban design, traffic, retail/commercial, environmental and phasing implications of the proposed growth and how this can be integrated into the Town's existing downtown area.

As such, the Town of Milton is hosting a Public Open House / Public Workshop to provide local residents and landowners/developers with an opportunity to offer opinions on where the growth should and should not occur within Milton's Urban Growth Centre and Built Boundary Area and what other issues should be taken into account within the Study. The information gathered from the Public Open House / Public Workshop combined with local staff's internal review will lead to the creation of recommended directions for where and how this growth shall occur. This meeting is an informal information session/open house and not a formal public meeting under the Planning Act.
