### MAIN STREET RECONSTRUCTION / REALIGNMENT -BRONTE STREET WESTERLY 0.8 KM CLASS ENVIRONMENTAL ASSESSMENT STUDY NOTICE OF FILING OF ENVIRONMENTAL STUDY REPORT

The Town of Milton has completed a Class Environmental Assessment (Class EA) Study for the proposed reconstruction and realignment of Main Street from Bronte Street westerly approximately 0.8 km. The Class EA Study was undertaken in accordance with Schedule 'C' of the Municipal Class Environmental Assessment process, which is approved under the Ontario Environmental Assessment Act.

Following the May 27, 2010 Public Information Centre, the preferred alternative was reviewed in light of comments received. Taking into consideration the comments that were received from regulatory agencies and the public, the recommended alternative includes:

- widening of Main Street between Bronte Street and Scott Boulevard to include two through lane (one lane in each direction), and a centre shared turn lane between Bronte Street and Whitmer Street
- on street bike lanes between Scott Boulevard and Whitmer Street
- multi-use path / sidewalk on both sides of the road between Bronte Street and Scott Boulevard (due to constraint at the CNR structure, the multiuse path will be provided by introducing pedestrian tunnels on either side of the CNR structure)
- signalized intersection at Scott Boulevard

The decision making process of the EA Study has been documented in an Environmental Study Report, which is available for review starting Monday, January 31, 2011 at the following locations during regular business hours:

between January 1 and February 1 this year, about 3,300 were either false, inappropriate or pocket dials, Maher added.

Some of his suggestions to avoid making erroneous emergency calls include taking SIM cards out of phones before giving them to children, or not allowing children to make phone calls, and removing 9-1-1 from the speed dial.

Maher said people also need to better familiarize themselves with the use of the line for emergency calls only.

He cited "surprising" instances where someone called 9-1-1 to ask if he was able to park on a certain street and another called to ask if the roads were safe for him to travel on during a recent snowfall.
