In Newmarket Thursday, the IceHawks grabbed perhaps their


biggest point of the year — rallying from a two-goal deficit before being vanquished 3-2 in overtime by the

Johannsen knotted things up with third-period goals, while back-up goalie Denny Dubblestyne turned back 31 shots.


