

Bus bike rack demos on tomorrow

The Town of Milton will host three demonstration sessions tomorrow on how to use the bicycle racks that have been placed on the front of Milton Transit's low floor buses.

The racks are located on the front bumper of the vehicle and can hold two bikes, but tricycles and bikes with child carriers or trailers aren't permitted.

The demonstration sessions will take place as follows:

9 to 11 a.m. at the Milton Sports Centre, 605 Santa Maria Blvd.

1 to 3 p.m. at the Milton Leisure Centre,

1100 Main St. E.

3 to 5 p.m. at Spokes 'N Slopes, 89 Ontario St.

Attendees will have the opportunity to fill out a ballot for a draw of a Norco Scorch mountain bike, courtesy of Spokes 'N Slopes.

For commuters, GO Transit buses are also equipped with bike racks. However, due to rush-hour crowding, GO's website states riders cannot bring their bikes on trains scheduled to arrive at Union Station between 6:30 and 9:30 a.m. or that leave Union Station between 3:30 and 6:30 p.m.

federal public health officials on other points, including preparation for mass immunization clinics.

A vaccine against the pH1N1 virus may not be available until well into November, said Nosal. However, in October, the Region will start its annual clinics to give residents their seasonal flu shots — the vaccine administered for free annually across Ontario.

Though this vaccine prevents three strains of Influenza A and B, not pH1N1, Nosal believes concerned residents will take advantage of the clinics.

The scale of subsequent pH1N1 vaccination clinics will depend on whether the virus has been observed to be dangerous and, if so, to what target groups, said Nosal.

"We certainly won't be getting hundreds of thousands of doses (of pH1N1 vaccine) right off the bat," he added.

Currently, the health department plans to communicate the same message to Halton residents that it put out this past spring — namely, prevent the spread of the virus by washing hands frequently, cough into a sleeve or tissue and stay home from work or school when sick.

Nosal said his department's recommendations are compatible with those being made provincially, meaning it is not recommending school closures at this time nor is it suggesting pregnant women refrain from working.

Pre-Authorized Tax Payments

The Town of Milton has introduced a 12-month pre-authorized property tax payment plan (PTP) to replace the existing 10-month program. The last withdrawal date for the current year will be November 2, 2009 and the first payment towards 2010 on the new 12-month program will be withdrawn on November 30, 2009.

If you are currently enrolled in the 10-month PTP, a letter of explanation, along with a tear-off authorization slip has been mailed to you. To continue with the new 12-month payment program, please send the signed slip back to the Town no later than **Friday, October 30, 2009**.

Without this authorization, the Town must legally remove you from the PTP program and future billings will be based on the regularly scheduled four instalments per year. If you are currently enrolled in the 10-month plan and did not receive the program change form, please call the phone number listed below and duplicate will be mailed to you.

Zoning By-Law - Notice of Passing

TAKE NOTICE THAT the Council of the Corporation of the Town of Milton passed **By-law Number 105-2009** on the **24th day of August 2009** under Section 34 of The Planning Act, R.S.O. 1990, as amended. This by-law amends the Town of Milton Zoning By-law #144-2003.

SHOULD YOU WISH TO APPEAL this by-law, you may appeal to The Ontario Municipal Board by filing with the Town Clerk of the Corporation of the Town of Milton. A copy of the appropriate appeal form is available from the Ontario Municipal Board website at www.omb.gov.on.ca or by contacting the Town Clerk's Division at 905-878-7252 #2131. Please choose Appellant Form (A1). This form must be accompanied with \$125.00 payable by certified cheque or money order to the Minister of Finance and must be filed with the Clerk's Division of the Town of Milton, at the address listed below, **not later than the 17th day of September 2009**.

Only individuals, corporations and public bodies may appeal a zoning by-law to The Ontario Municipal Board. A Notice of Appeal may not be filed by an unincorporated association or group. However, a Notice of Appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

EXPLANATORY NOTE

By-law 105-2009 amends the Town of Milton Comprehensive Zoning By-law 144-2003, as amended.

The purpose and effect of this housekeeping amendment is to provide additional permissions and requirements relating to Carports and Restaurant Patios and to clarify wording and intent in various sections of the By-law.
