## Meeting on Aboriginal education

Halton's two English school boards will host a series of upcoming public meetings to gather feedback on a working draft policy they have jointly developed for Aboriginal self-identification.

The draft policy, developed by the boards' joint Aboriginal Education Advisory Committee (AEAC), is in line with the Provincial Ministry of Education's encouragement for school boards to develop policies on voluntary and confidential Aboriginal student self-identification.

Such policies could then be used as the basis to gather relevant information, states the AEAC.

There was an estimated Aboriginal population of 2,640 in Halton in 2006, of a total

population of 435,935, according to a report from Ontario's Trillium Foundation.

While that percentage is much smaller than Ontario and Canadian averages, the Aboriginal population in Halton grew 47 per cent from 2001 to 2006, the report notes.

The ministry has identified Aboriginal education as a key priority and by 2016, it wants to close the gap between Aboriginal and non-Aboriginal students in the areas of literacy and numeracy, graduation rates and advancement to post-secondary studies.
