

NOTICE OF STUDY COMPLETION/ CLASS ENVIRONMENTAL ASSESSMENT STUDY

Municipal Class Environmental Assessment for Mid Halton Wastewater Treatment Plant Phase IV & V Expansion and Trunk Sewer from Boyne Pumping Station to Dundas Street (Regional Road 5)/Third Line, Town of Milton/Town of Oakville PR-2583A and PR-2584A

Background

Halton Region has completed the 2008 South Halton Water and Wastewater Master Plan Update. This Master Plan Update identified the need to expand the Mid Halton Wastewater Treatment Plant and to construct a new trunk sewer from Boyne Pumping Station to Dundas Street/Third Line to support Regional growth to the year 2021 (refer to map for Study Areas). Separate studies were conducted for both of these projects in accordance with Schedule C of the Municipal Class Environment Assessment Document (October 2000 as amended in 2007), which is approved under the Ontario Environment Assessment Act.

The Process

As a part of the Environmental Assessment (EA) studies, Public Information Centre (PIC) meetings were held on May 14, 2009 and October 1, 2009. The first PIC outlined the background information, proposed a decision making approach, presented a long list of alternatives, as well as screening criteria, and the detailed evaluation criteria. The second PIC recommended preferred design alternatives identified through the screening and detailed evaluation processes. Based on input received at these PICs as well as input from review agencies and other key stakeholders, the Region and its consultants have prepared the Environmental Study Report (ESR) for each of these projects.

Environmental Study Report (ESR)

By this Notice, the ESR is being placed on the public record for review in accordance with the requirement of the Municipal Class Environmental Assessment process. Subject to comments received as a result of this Notice and the receipt of all necessary approvals, Halton Region intends to proceed with the detailed design and construction as documented in the ESR.

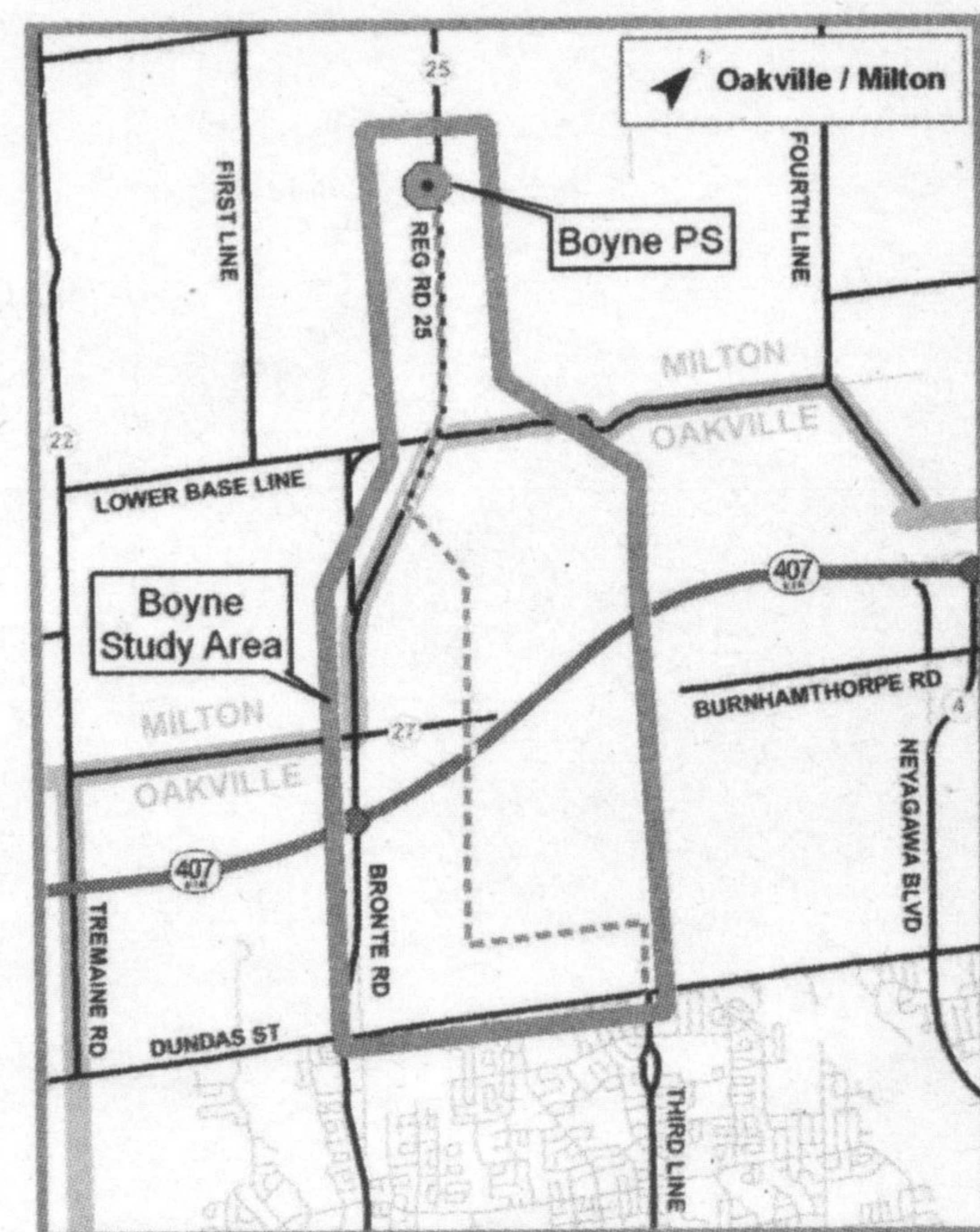
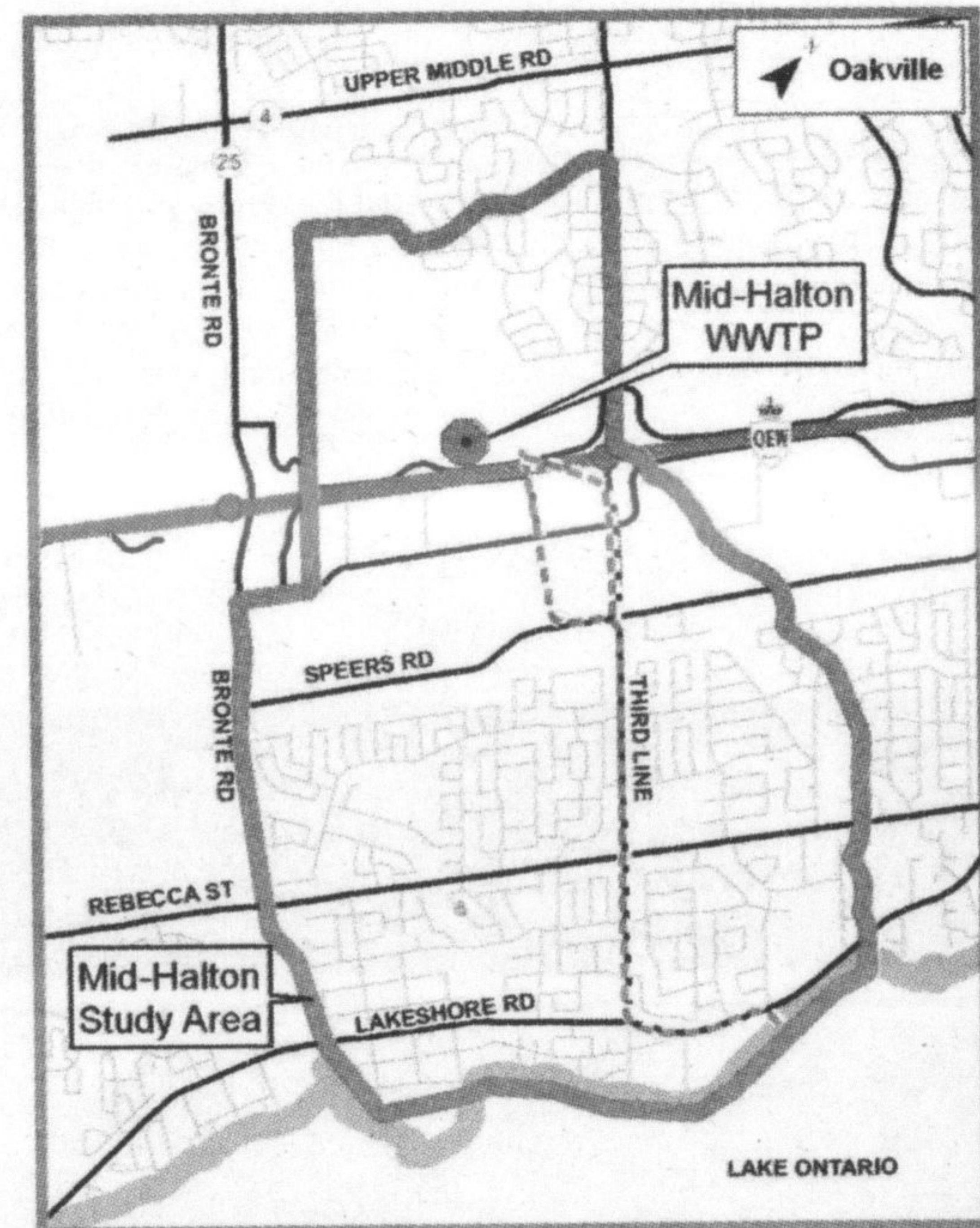
