Ratepayers of the Town of Milton are reminded that the first installment of the 2010 Final Tax bill will be due on Wednesday, June 30, 2010.

If you require information about taxes, please contact the Corporate Services, Tax Division at 905-878-7252 ext. 2193, from 8:30 a.m. to 4:30 p.m. Monday to Friday.

Tax payments must be received by The Town of Milton on or before the due date to avoid penalty. A late payment charge of 1.25% will be charged on the first day of default and on the first day of each calendar month in which the default continues.

It is the responsibility of the ratepayer to ensure that the taxes are paid by the due date, even in the event that the bill is not received by mail.

- > By deposit into the After Hours Drop Box, Town Hall.
- > Cheques are payable to the Town of Milton.
