## Oakville trustee remains chair of Catholic board

The longest serving trustee with the Halton District School Board is once again its chair, while a returning Burlington trustee is the new vice-chair.

Alice Anne LeMay, an Oakville trustee since 1980, was acclaimed as chair of the board for a one-year term at the trustee inauguration and swearing-in ceremony held last Tuesday evening at Holy Trinity Secondary School in Oakville.

Arlene Lantomas, re-elected in

Burlington's Wards 1 and 2 in the October 25 municipal election, has begun her second go-round at the board table and will do so as its vice-chair after being running unopposed for the position.

LeMay was nominated for board chair by new Burlington Trustee John Morrison, with the motion seconded by longtime Oakville Trustee Ed Viana.

Having served as the board's chair previously in two consecutive terms from December 1994 to December 1996, and again from September 2007 to December

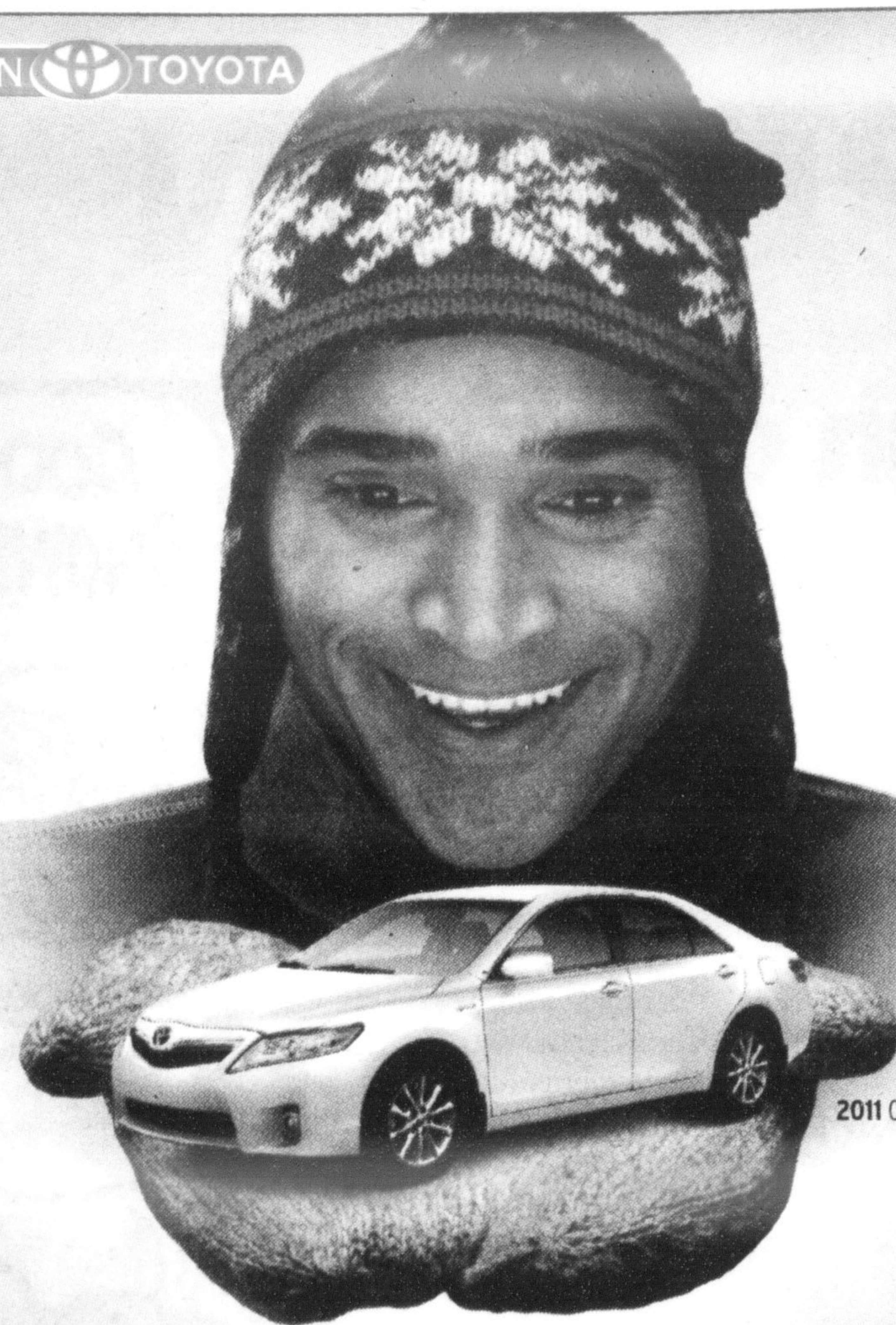

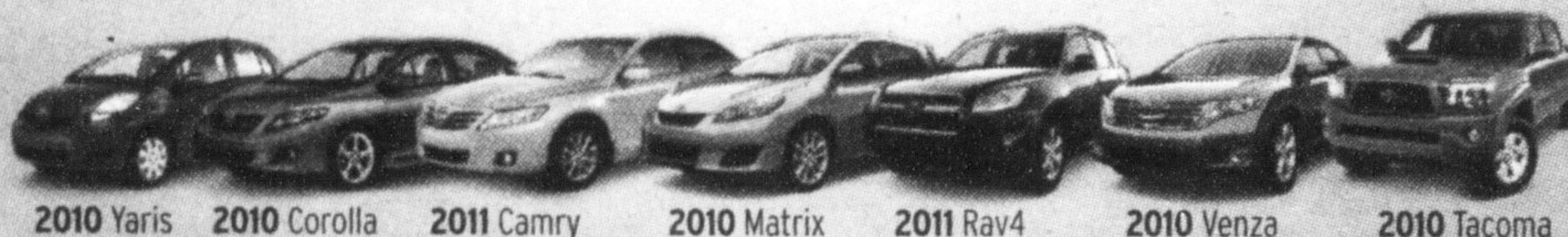
