Region's tax bite may be 7.1 per cent bigger in 1989

Property taxes will go up 7.1 per cent if Halton's proposed budget is approved later in 1989.

In a preliminary document released last week, regional staff announced they would try to toe the line close to the 7 per cent increase they had set as a target for this year in 1988.

Since then, however, some things have changed. Provincial unconditional grants have been effectively, frozen. Also, regional staff thought their perceptions of growth were conservative," during initial planning, Halton chief administrative officer John Fleming said. Instead, those predictions "were accurate."

The freezing of unconditional grants had a \$610,000 debit impact on Halton financing. Mr. Fleming noted,

Unconditional grants are transfer payments which were established by the province as a means of helping municipal governments bolster their general revenue.

They are in addition to the specifically targeted funds which the province applies to various municipal projects.

While not on the same level of magnitude as provincial matching grants, the unconditional allowances have a substantial impact on property tax rates, according to regional calculations.

In 1988 such grants represented an amount equal to almost 30 per cent of the regional property taxes. If the grants stay frozen at 1988 levels, they will decline to an amount equalling 16 per cent of the property taxes by 1994. That shortfall will have to be made up somehow.

Based on the preceding formula Halton would have obtained \$11.3 million in uncondtional grants. Instead the region wound up with \$10.7 million, a drop equal to half a percent of the total property taxes.

The regional portion of property taxes will rise to almost \$233 for an average-assessed home in 1989 with the 7.1 per cent bump, up from \$217.18 in 1988.

The expenditures were rounded out by the regional property tax portion, \$217, and solid waste disposal fees of \$31 per household.

Regional finance director Joe Rinaldo said the province appears to be shifting the tax burden onto local government. Property tax increases are seen as a regressive tax, Mr. Rinaldo said, because they increase the burden on the lower income earners. Provincially controlled taxes, such as sales tax, tend to hit more affluent people, he said.


At the same time grants are being reduced, municipalities are faced with increased expenditures because of higher standards imposed by the province, Mr. Rinaldo said


