Chamber slams plan to cut garbage collection

In what town public works director John Matthews admits will be an unpopular move, Milton will exclude 135 businesses from municipal garbage collection as of December.

Tuesday night council approved in principle a bylaw which will mean garbage pick-up by zoning.

Residences and general commercial businesses in the urban area will continue to receive weekly collection, but more industrially-oriented concerns in the core bounded by Steeles Avenue, Bronte Road, Derry Road and Thompson Road will no longer get a collection.

It only remains for council to rubber-stamp the bylaw, probably at the September 18 meeting. The matter provoked no discussion at council Tuesday. It had already been decided during preliminary discussions on the subject in May. An open house on the issue in June drew only five

Commerce views the proposal as un-

fair. In a letter to council, Chamber president Bob Lawrence said the move will only heighten "existing inequalities" in garbage collection.

Mr. Lawrence pointed out that urban ratepayers face a higher tax burden than their rural conterparts because they are also entitled to more municipal services, such as garbage collection. "Under the proposed changes, segments of the business community are going to be paying for a service which they will be denied," Mr. Lawrence wrote.

Mr. Matthews first presented council with a range of collection possibilities in May, including collection only from residences, no change to the current collection policy (which includes many businesses and most residences), and variations in between. Council chose the limited commercial collection.

It has been town policy for some time to refuse garbage collection to all new businesses in Milton, which people.

However, Milton's Chamber of has aggravated many commercial operation proprietors who see older

businesses similar to their own getting collection, Mr. Matthews noted.

The new bylaw is expected to provide a level playing field in that all light commercial enterprises will get collection. The others will be forced

to purchase private collection.

Mr. Matthews indicated in his report the situation could be reviewed if Milton is, as expected, saddled with Halton's new landfill site. Milton has been chosen for the dump, but the

town is appealing the decision.

If the huge dump comes to rural Milton, travel time for garbage trucks will be cut, Mr. Matthews noted, which means service levels could possibly be increased again.


