A&P not charged for opening on Sunday

The A & P store in Milton defied provincial law in remaining open last Sunday but they were not charged under the Retail Business Holidays Act and no one seems to know why.

Halton Regional Police suggested the lack of charges might have been an oversight on their part. They were unable to determine the exact reason no charges were laid. Sergeant Frank Phillips said that the situation will be monitored this weekend.

The store and others around the province will open again this Sunday according to Linda Weichel, spokesperson for the Committee For Fair Shopping, a lobby group formed by four major grocery retailers. The maximum penalty for opening is a fine of \$50,000. Brent Kearse, Executive Director of Halton Region Business Development Office, said the fines are usually in the range of \$500 to \$5,000.

Survey cards were available at the stores to give shoppers a chance to express their opinions about the Sunday openings. Some other businesses are watching the developments closely and making noises about opening said Mr. Kearse. "Retailers are eyeing the large Christmas market and that might affect their decision," he added.

Ms Weichel said that 56 of the 80 grocery stores open in Halton, York, Peel and Niagara Regions were charged under the provincial legislation. The Committee For Fair Shopping has been lobbying municipal governments see A&P on page 2,
