This letter is necessitated by the Champion's continued printing of Jeff Pasquale's quasi-factual and extremely negative personal comments about the Milton Minor Hockey Association.

called Jeff two weeks ago on a Friday evening as soon as I read the highly critical 'Terry Brandt/Milton Hockey" article (Champion, Oct. 20). This article was full of assumptions, errors and one-sided viewpoints and was very damaging to a large group of volunteers who certainly deserve better treatment than this.

Jeff admitted being misinformed and in some cases wrong and promised to look into the facts further. At this point, I expected to see a retraction or at least a more correct version of Jeff's initial attempt at reporting this matter. You will recall that my reasons for being upset with the first article were as follows:

1. The Champion apparently has little or no space available to write about MMHA teams or results, however you can justify almost half a page dedicated to your perception of the political wrongs of our association and its volunteer members.

2. Ian Ellis should be playing hockey and it is not our intention to prevent this from happening. We do not volunteer our time with the intention of discouraging boys from playing hockey.

3. The midget convener (Darrell Taylor), the coach of the major midget AA team (Peter McDuffe) and I spent several hours working out a fair and reasonable compromise for lan Ellis' situation. We hoped this would beneplaying again. This was proposed to lan's father more than three weeks ago and to date there's been no response.

4. Other 16-year-old midget plavers were in the same position as Ellis regarding being forced to sign a minor card and play for the minor AA team, even if they were good enough to make the major AA team. What is good for one is good for all, and Ellis wasn't going to get special consideration.

Instead of the anticipated retraction, or a more factually correct version, I read yet another slanted version of this matter on Friday Nov. 3 - "lan Ellis case is tragic." I guess all the effort I spent attempting to explain this matter has been for nothing.

Once again, out of context statements and misinterpreted facts dominate the headlines. You are right in one area; the fact a very capable 16year- old hockey player is not allowed to play is indeed tragic. How-

ever, it is equally tragic that the bottom-line reason for this boy not playing has nothing to do with MMHA or the people involved. An equitable solution was offered and has been

refused so far, for reasons unknown. Your recent article takes the liberty of quoting me out of context and I object to this very strongly.

1. I have been very involved in trying to get lan Ellis returned to playing status as quickly as possible.

2. I was prepared to and in fact did offer compromises concerning the minor midget AA team's supposed rights to lan, as a means of resolving this problem.

3. I care very much about situations like this and never stated that I didn't care where lan played. The fact I was prepared to compromise doesn't constitute not caring where he plays.

4. I knew I had to draw replacements from house league. Although I am not in favour of this option, I was told our team had to draw horizontally - end of discussion.

5. I don't believe lan Ellis had any guarantee of signing a major card. MMHA took a stand on midget hockey before this season started, making it impossible for any 16-yearold who didn't play major bantam AA in Milton last year to sign with the major midget team this year.

6. Ian Ellis is suspended for signing a major card when this option was not available to him - this is correct.

7. My son was not the only player caught in this position of possibly being capable enough to make the major midget AA team but not being allowed to do so. Your comment on this matter appears to insinuate that would have personal reasons to see that Ian Ellis gets no help from me with his "problem." lan Ellis is not fit everyone involved and get lan the only one who had to face this situation right, wrong or otherwise.

8. Milton Minor Hockey would have a hard time creating special considerations for one player when others who have played in Milton all of the time are being treated differently.

I am at a loss to understand the Champion focusing all this attention on only negative editorials and the woes of one player. Many good things happen in our hockey organization which deserve your attention as well. Do you realize that for the first time in two years we now have boys playing hockey again at the juvenile, major and minor midget rep levels?

This represents three new teams and quality competition for 40 to 50 Milton boys who might otherwise be out of hockey by now. "As I see it," these are the kind of newsworthy things which should be written about to keep minor hockey on a positive note, and to let the volun-

teers involved see that their efforts expose them to more than just highly-critical sports columns.


