

Q. Being a working mother, I have always made the claim for child care expenses on my return. Last year my net income was considerably higher than my husband's. May I still make the . claim on my return?

A. No. Only the spouse having the lower net income (before deducting child care expenses) may claim child care expenses. Since you have the higher net income, you may claim expenses only if there were periods during which your husband was separated and living apart from you (minimum three months), in full-time attendance at a designated educational institution, or infirm or in an institution for at least two weeks.

A PUBLIC SERVICE OF HAR BLOCK

Q. I received all my pension contributions back from my employer and noticed that 10 percent was deducted for income tax. Do I have to report the money on my tax return even though my employer deducted the 10 percent?

A. Yes, you do. You will however, be able to claim the 10% as a credit for tax withheld at source.
