

# Drury wins final three games but nudged out of playoff berth

The E.C. Drury High School baseball team finished the season on a high note by defeating second-place Oakville Trafalgar High School 7-2 Friday in Oakville.

Their 4-4 record left them in fifth place and out of the playoffs.

A shorthanded last inning loss to Queen Elizabeth Park proved to be

the damaging defeat.

Even though ECD won their final three games by a combined score of 37-6, their fate was sealed when OTHS defeated Milton District High School earlier in the week.

In Friday's game Jim Fenn made his first career start a memorable one as he tossed four innings of no hit ball.

Only two runners reached base, one on a walk, the other an error.

Fenn erased one of the runners on a well executed pickoff play at third base. He only managed to strike out one.

Kevin O'Donnell, who took over on the hill in the fifth, was named

ECD's Player of the Year this season.

He gave up two runs on a walk, a double and an error.

Scott Holloway, in his first game back after having his appendix removed, threw a shutout sixth to finish it off.

Offensively, Fenn led the way with two hits and one RBI.

Drury only mustered seven hits but took advantage of four OTHS errors in the fifth to score four.

Other hitters included Damien Dubien, Glen McCallister, Rob Del Papa, James Janjevich and Rick O'Donnell. O'Donnell played well in left field, making several fine defensive plays.

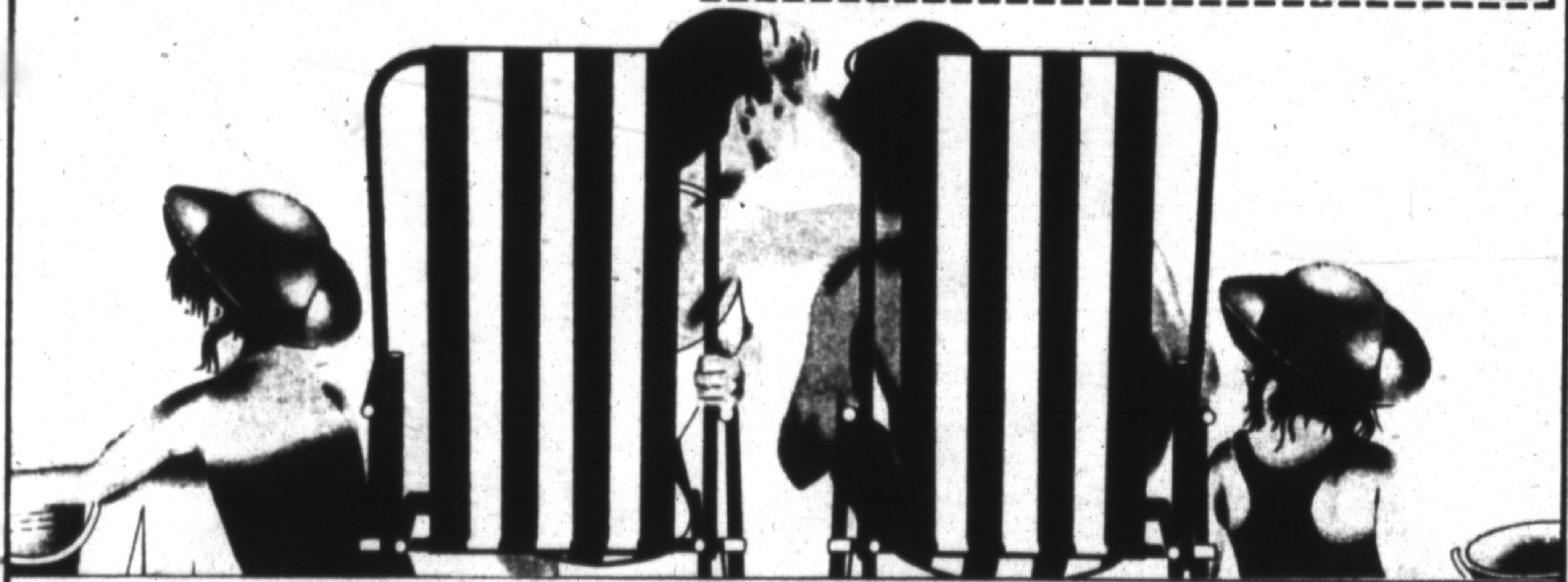
