## Halton targets Bell to defray costs of phone book

For example, "in the past we were receiving \$25 a tonne" for the phone books, Mr. Leitch noted. Even that "nowhere near covered the cost" of picking them up. To make matters worse, "recently the revenue dropped from \$25 to zero."

Burlington councillor Barry Quinn, while acknowledging that "singling out Bell" was "a start," said "there are two sides to this story, for crying out loud. There's much more to this whole

thing than hitting Bell for a telephone book."

The phone company will probably just pass the cost on to its customers and "I don't want to pay a whole lot more to get a telephone book," councillor Quinn said. "If we hit Bell real hard, they're going to hit us back."

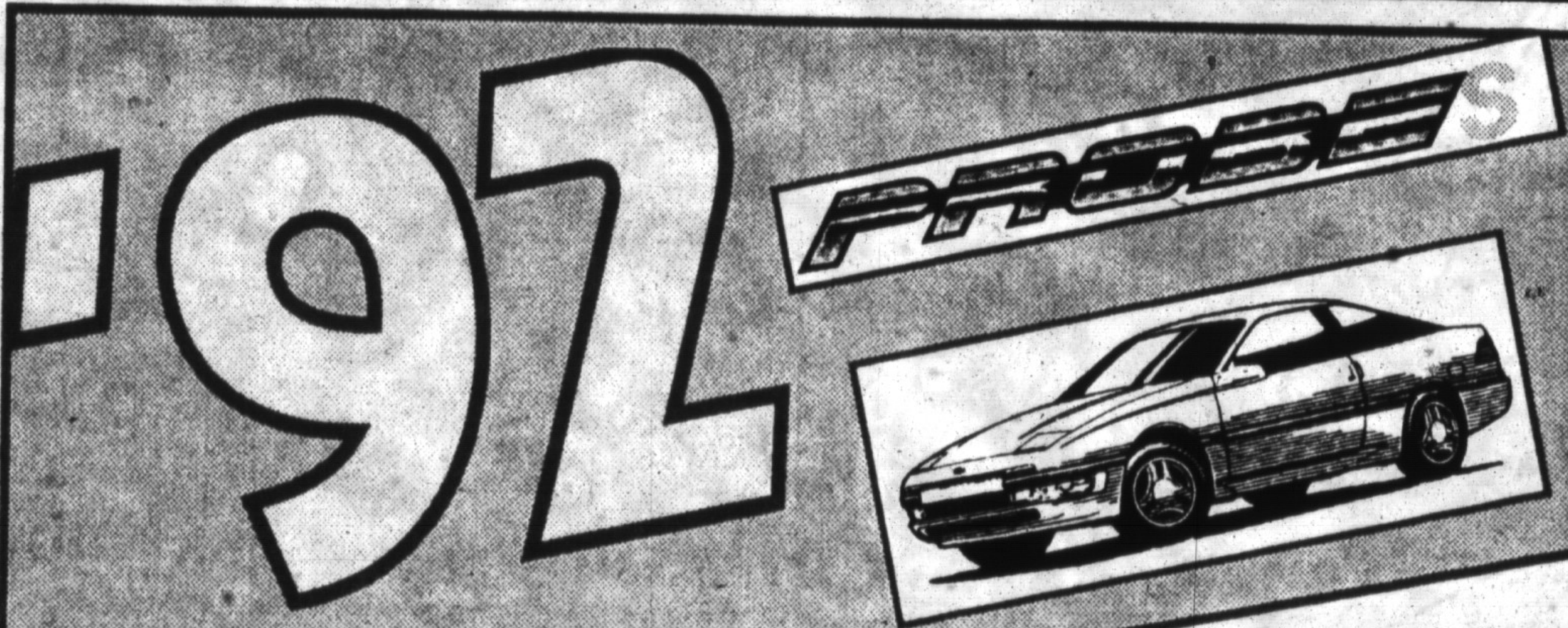
"I agree with going back to the manufacturer to defray costs," Burlington councillor Joyce Savoline said. If Bell passes that expense on, "so be it." The recycling fee should be borne by phone

company customers, "and not on the tax bill," councillor Savoline added. "The tax bill can't endure this type of thing."

Mr. Quinn said he supports pushing the provincial government to make all firms absorb more of the recycling costs for products they generate. However, "I don't think we should be picking them off one at a time. There are a whole pile of people out there who are causing us problems. To single out one, I don't think, is very proper."
