## Debate continues despite deal to fund farm water

and fall of 1991 were the causes of the Winters' problems.

Thursday Mrs. Winter said Mr. Meneray's report is deeply flawed. Now that she has seen the previously confidenial text, she will be sending what amounts to a rebuttal to Halton

regional chairman Peter Pomeroy, she added.

Although councillors voted 17-2 to provide trucked-in water for the Winter farm until an-depth investigation can hopefully determine what the underlying problem is, Burlington councillor Doug Greenaway.

triggered a debate by saying he was against the move.

"I'd like to go on record as opposing this method to solve the problem," councillor Greenaway said.
According to Mr. Meneray's report,
"the problems were there before we
started" landfill construction. Mr.

Greenaway urged fellow councillors to "turn this down."

But Halton Hills councillor Marilyn Serjeantson, who chairs the regional committee which initially endorsed supplying water to the Winter farm, said councillors are facing "a delicate situation."

Because of controversy in other areas of Ontario about potential dumpsite locations, "people from all over the province are looking at how we handle this. We don't need all this adverse publicity," councillor Serjeantson said. "It's time that we solve this problem. There's a lot at stake."

"Where's the cutoff point?" asked councillor Greenaway, in reference to how far Halton should go in assuming responsibility for water shortages near the landfill. "At what point do you stop?"

Councillor Serjeantson said the Winters' dairy operation was the "only case" in which such actions are proposed.

Oakville councillor Kevin Flynn stressed the underlying message in approving only a temporary move to assist the farm family. "This may not be our problem to solve," Mr. Flynn noted. "If it is not our fault, I don't think we have an obligation to fix it."

But Burlington councillor Bob Brechin said councillor Serjeantson "hit the nail on the head. If I lived where the Winters did I would certainly be pointing at the region" as the source of difficulties.

Mr. Brechin, like Mr. Pomeroy, appears to be leaning toward straightening out the Winters' problems at regional expense even if it means digging a new well, something that Mr. Meneray estimated could cost \$15,000.

"For the amount of money involved I don't want to consume our energies, that of (regional) staff, the Winters. I'm prepared to stop the bickering."

Halton has agreed to pay for a consultant's study aimed at finding out if the landfill has reduced underground water flows to the farm. The Winters are free to hire any qualified firm they wish to undertake the work, and both parties have agreed to live by the findings.
