Here they are, the leading job creators year-in and year-out, the lifeblood of communities throughout Canada . . . There they go, battered by government taxes and regulation, barely surviving this harsh recession.

This sector is essential to Canada's future prosperity. Unfortunately, most governments have yet to understand this. In fact, the federal government and its appointed "Prosperity Group" basically ignored this important group of businesses in the recently released report, Inventing our Future: An Action Plan for Canada's Prosperity. While there are some laudable recommendations about expenditure restraint, tax decrease's and interprovincial trade barriers, the report blatantly reflects the big business agenda for the 1990's - small businesses were left out of the equation.

This was perhaps no accident. Some of the critical budget. competitiveness issues to small business are also some of the most embarrassing for the federal government: the Goods and Services Tax, cross-border shopping, the underground economy and the crippled tourism sector. None were properly addressed by the Prosperity Group; all are crucial to the prospects for prosperity for small business in particular, and Canadians in general.

However, Mr. Clements hammered home the point that while industrial sector taxes may increase, commercial (mostly retail) businesses would see an overall drop.


"It's true that in the commercial area taxes will decrease \$325,000, correct?" he asked Ms Martin.

PUBLIC INFORMATION MEETING DEVELOPMENT CHARGES: REVISED POLICY PROPOSALS

The Council of the Regional Municipality of Halton passed Bylaws Nos. 66-91, 67-91, 68-91, 69-91 and 70-91 on April 17, 1991, under section 4 of the Development Charges Act, 1989 to enact new development charges and policies. Now, the Region is considering adopting new by-laws.

As part of the process, Halton conducted a policy review of its current development charge policies and procedures. A Public Information Meeting pursuant to subsection 6(6) of the Act was held on May 7, 1992. Comments were received from the public in writing, and submissions were received at the Public Information Meeting. Subsequently, Regional Staff prepared draft proposals based on the policy review and the public comments.

A Public Information Meeting pursuant to section 4 of the Development Charges Act, 1989, was held on September 30, 1992. At the meeting, staff informed the public of draft proposals under consideration. Additional public comments were received, and revised development charge proposals have since been prepared. The revised proposals represent refinements and modifications to the draft proposals previously presented and are based on the public input received to date.
