The trial of a counsellor at the Ernest C. Drury School for the Deaf, who faces sexual assault charges involving former students, has been set for May

Harvey Bradley, 46, of Merritt Drive, who made a brief court appearance in Milton Monday, is charged with a series of sex-related offences which are alleged to have taken place between May, 1972 and June, 1980.

Mr. Bradley, who is hearing impaired, has been suspended with pay since ; charges were laid in October last year.

The trial is expected to last three weeks.
