Big BMX race starts Thursday

A prestigious BMX tournament will take place at Milton's Drumquin Park this week, as expert riders from across North America flock to the Maple Leaf National competition. It marks the first time the race has been held outside the United States.

Events at the Milton Track 2000 location get underway tomorrow (Thursday), with national-calibre competition on Saturday and Sunday, beginning at 11 a.m. and 8 a.m. respectively.

The park is located at the intersection of Trafalgar and Britannia roads.

Charity golf tournament

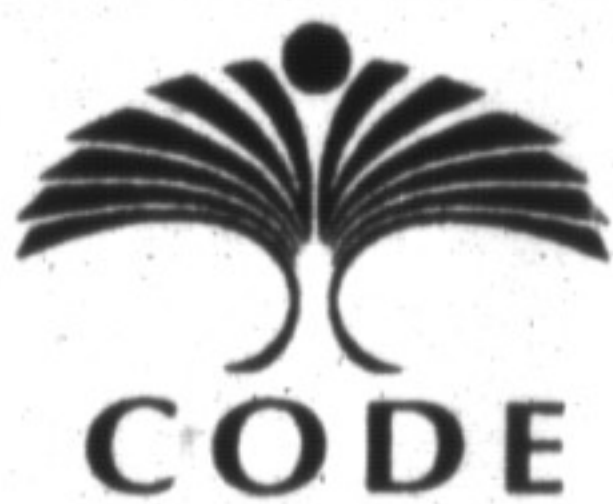

EXPROPRIATIONS ACT

NOTICE OF APPLICATION FOR APPROVAL TO EXPROPRIATE LAND

IN THE MATTER OF an application by

HER MAJESTY THE QUEEN IN RIGHT OF ONTARIO as represented by THE CHAIR of the MANAGEMENT BOARD OF CABINET (Expropriating Authority)

for approval to expropriate land being part of the Town of Oakville and the Town of Milton in the Regional Municipality of Halton in the Province of Ontario, as described on the attached Schedules "A" and "B";

for the purpose of acquiring lands for the future construction of Highway 403 at its intersections with Sixth Line and Trafalgar Road in the Town of Milton and the Town of Oakville and the Town of Milton on behalf of the Minister of Transportation pursuant to the Ministry of Government Services Act, R.S.O. 1990 c. M.25, sec. 7 subsec. 4.

NOTICE IS HEREBY GIVEN that application has been made for approval to expropriate the lands described as follows:

All right, title, and interest in lands described in Schedule "A" attached, and a limited estate, right or interest required temporarily for a period of five (5) years from the date of registration of the Plan(s) of Expropriation in the lands described in Schedule "B" attached. A definition of the limited estates, rights or interest required in the lands described in Schedule "B" appears in Schedule "C".

Any owner of lands in respect of which notice is given who desires an inquiry into whether the taking of such land is fair, sound and reasonably necessary in the achievement of the objectives of the expropriating authority shall so notify the approving authority in writing.

- (a) in the case of a registered owner, served personally or by registered mail within thirty days after he is served with the notice, or, when he is served by publication, within thirty days after the first publication of the notice;
- (b) in the case of an owner who is not a registered owner, within thirty days after the first publication of the notice.

NOTES:

1. The Expropriations Act Provides that,

- (a) where an inquiry is requested, it shall be conducted by an inquiry officer appointed by the Attorney General.
- (b) the inquiry officer,
 - (i) shall give every party to the enquiry an opportunity to present evidence and argument and to examine and cross-examine witnesses, either personally by his counsel or agent, and
 - (ii) may recommend to the approving authority that a party to the inquiry be paid a fixed amount for his costs of the inquiry not to exceed \$200, and the approving authority may in its discretion order the expropriating authority to pay such costs forthwith.

2. "owner" and "registered owner" are defined in the Act as follows:

"owner" includes a mortgagee, tenant, execution creditor, a person entitled to a limited estate or interest in land, a committee of the estate of a mentally incompetent person or of a person incapable of managing his affairs, and a guardian, executor, administrator or trustee in whom land is vested;

"registered owner" means an owner of land whose interest in the land is defined and whose name is specified in an instrument in the proper land registry or sheriff's office, and includes a person shown as a tenant of land on the last revised assessment roll.

3. The expropriating authority, each owner who notifies the approving authority that he desires a hearing in respect of the lands intended to be expropriated and any owner added as a party by the inquiry offices are parties to the inquiry.

SCHEDULE "C"

Definition of Estate, Right or Interest required

Temporary Easement:

A temporary limited estate required in the right and easement:

- (a) to enter and construct new or replacement access roads where required;
- (b) to enter and grade the lands described as required, as necessary or incidental thereto, on, in, across, under and through the lands;
- (c) to keep the lands described clear of all brush, trees, and other obstructions of any nature whatsoever, including removal of any buildings, as may be necessary to the exercise and enjoyment of the rights and easements herein set forth;
- (d) for the Expropriating Authority, its assigns, servants, agents, contractors, workmen and other duly authorized persons at all times and from time to time to pass and repass with all plant, machinery, vehicles and equipment as may be necessary above, over, under and through the lands described for all purposes necessary or incidental to the exercise and for the enjoyment of the rights and easements herein set forth.
