## Town worried defunct plant will fester environmentally

The abandoned site of the former Pigment & Chemical company wasn't mentioned but must have lurked in town councillors' minds last week as they heard staff review proposed provincial guidelines for contaminated site clean-up.

A staff critique of the guidelines, designed to be followed voluntarily by the property owner with minimum Ministry of Environment & Energy (MOEE) involvement, has staff worried because it appears to apply only to viable sites - not "orphaned" sites — ones which are for all intents abandoned.

."There is a conspicuous absence of any type of mechanism to deal with an orphan site," building and enforcement director John DeVries told the Town's general committee.

Mr. DeVries complained the guideline is tailored to viable development sites. "Often orphaned sites are in the greatest need of remediation," he said.

"Structures on the site tend to focus the attention of the community, draining its resources as a result of vandalism, arson and other associated health concerns," said the report.

## Good deed at orchard

Neither Mr. De Vries, nor any councillor, linked the abandoned Main Street East site to the report's comments on "orphaned sites." Asked about the site, Mr. DeVries said, "For all intents and purposes, Pigment & Chemical has gone out of business. The Town is going to continue to attempt to see if we can have the buildings on site demolished."

But that won't be easy. Late last June, Mayor Gord Krantz wrote to Environment Minister Bud Wildman about the property, stating, "the Town attaches the greatest priority to the removal and disposal of the transportable chemicals and the demolition of the buildings on the site."

Mr. DeVries said the last of the transportable, hazardous chemicals were removed from the site Aug. 30. The property is registered to Pigment & Chemical Inc., which is no longer in operation. The Royal Bank

of Canada holds the first mortgage. According to Mr. Krantz's letter. the site's buildings and soils are contaminated and the bank's position is that it has no responsibility for further property clean-up. "You can't blame them," said Mr. De Vries noting potential liabilities.

"The Town continues to work at communicating with the bank." Those ongoing discussions could determine the site's future, said Mr. De Vries.

In his June letter, Mr. Krantz said

the MOEE district office advised the of Canada, it would not be in the best site's buildings and contents were reasonably secure. However, the Mayor wrote, "It remains a serious concern that someone will manage to gain access to the premises. Therefore the Town considers it to be of critical importance that the hazardous chemicals and the buildings be removed as soon as possible."

In a response that went to council in late August, Mr. Wildman wrote, "I have been advised the buildings are not contaminated and pose no environmental hazard or public health threat to the citizens of Milton. In consideration of the fact the first

In mid-August, two boys aged 13 and 14 were charged with break and enter, and arson in the wake of a fire at the site. Police said entry was gained through an insecure door.

Town staff will go to the Province with specific recommendations on the guidelines including; allowance for demolition of buildings on orphaned sites plagued by vandalism, arson or health concerns, and that municipalities be allowed to enter agreements with the MOEE permitting site mortgage is held by the Royal Bank remediation without future liability.




