Budget above Halton guidelines, cops try to toe line

The Halton Regional Police Services' \$38.2 million 1995 operating budget will be unveiled before Halton Region's administration and finance committee (Wednesday).

The budget, up \$287,200 (threequarters of one per cent) over last year, is also \$87,200 higher than regional council-approved guidelines. Earlier this fall, regional council ordered all regional bodies to flatline budgets at 1994 levels.

Halton Police Chief Peter Campbell and police services board Chair Barry Quinn are expected to put the budget

before the committee this afternoon.

"The police services board have requested that the 1995 budget be approved as submitted. However they will endeavour to maintain spending in 1995 at the council-approved guideline," says a report to the committee from regional treasurer Joe Rinaldo. Police hope to meet the Region's guideline by keeping numerous positions vacant in 1995, said Mr. Rinaldo's report.

Savings achieved in 1994 will be used to cover an anticipated \$750,000 cost attached to the use of new firearms — a provincial mandate requiring at least 65 hours in additional training for each local police officer.

The Halton police will also plan to add four new people to their ranks in 1995 — three uniformed officers and one civilian.

The three officers will be involved in the DARE (Drug Abuse Resistance Education) program but their positions won't be attached to the police budget, as one will be jointly funded by Halton's public and separate

school boards and the other two, funded by DARE Halton, a community fundraising group.

The new civilian position, a fire alarm coordinator to work with the police service's new mobile radio system, was approved in the 1994 budget. The new radio system is expected to be up and running by next fall.

The 1995 police capital budget

totals \$350,000 — \$270,000 of which will come from the tax-supported operating budget and \$80,000 from police reserves.

The 10-year capital forecast meets overall regional guidelines but an accelerated timing of projects within it puts the most impact on the 1996/1997 budget — at \$2.1 million and \$804,000, respectively. Requirements in other years don't go

above \$500,000 and remain at zero for several years.

"Staff are concerned with the accelerated timing of the projects," reported Mr. Rinaldo. Regional staff want to meet with the police to review the timing factor.

The police budget is expected to go before regional council, after its committee hearing today, next week for

Sib-Jel plan

Controversial housing approved

The Ontario Municipal Board (OMB) will allow Sib-Jel Investments to build 41 non-profit townhouses next to Milton's fairgrounds despite nearby residents' arguments that the project is incompatible with the area.

The decision was announced in a written ruling dated December 7. The reasoning behind the ruling isn't expected until later this month.

An OMB hearing on the issue began in Milton in August and wound up in Toronto last month.

Newly elected Ward 2 Councillor Wally Hunter had represented over 200 area residents in a fight against the project. The complex was seen as a high density development in what residents consider a lower density neighborhood.

The project will, however, serve to boost Milton's deficient quota for non-profit housing. Under NDP policy, 25 percent of new development must be affordable housing.

Sib-Jel lawyer Gordon Petch had pushed for an early decision by the OMB. Mr. Hunter wants the OMB to spell out its decision in writing so he


