Deoni ousted from committee over conflict woes

January was a rocky month for a couple of Halton public and Catholic school board trustees.

One member from each of those boards is no longer on their respective salary committee, in a year in which collective bargaining with various teaching and non-teaching unions will be a big issue.

On January 25 Burlington Trustee Joe Pavelka resigned

Education's salary negotiating committee. The 10-member panel had been confirmed by a 12-6 vote. However, the vocal minority balked at Mr. Pavelka's inclusion due to a perceived conflict of interest.

Then, at last week's regular meeting of the Halton Roman Catholic School Board, a terse one-sentence letter from Alice Anne LeMay, chair of the board, was included on the agenda. It informed Joe Deoni, Milton's Wards 1 and 3 trustee. that she had removed him from the board's salary committee.

There was much discussion at the meeting, some of it rancorous, about who should be on the three-person salary committee, which deals with teacher contracts. Very little, however, was said about Mr. Deoni's abrupt removal.

The board had received a letter from Robert Boyle, principal of Oakville's St. Luke's school. It suggested Mr. Deoni, then chair of the salary committee, had a conflict of interest because his son is a member of the Ontario Catholic Teachers Association bargaining unit.

Mr. Deoni made it clear to the board he expected the letter be accepted as information only, and not as an item on which the board should act. He said the law provides — and Ms LeMay agreed — that only a ratepayer, not the board or a teacher's union, can try to remove a trustee under these circumstances.

After the meeting Mr. Deoni, a seven-year member of the board's salary committee, was initially upset about being ousted, but later turned philosophical about the situation.

"Most trustees work around these conflicts," he stated. "(So) I've been trying to find out from the chair why I was removed. I don't have any idea. Whether I decide to appeal or not I don't know."

Softening his position somewhat, Mr. Deoni added, "I've known Bob Boyle for years. I don't think there was anything vindictive about this.

'I could be altruistic and say he was looking after my best interests," he added with a laugh

Ms LeMay said, 'The reason you may take someone off a committee is for the good of the whole board. I don't have to give an official reason (but) you can't get tied up in (conflicts of) personalities."

Oakville Trustee Kevin O'Connor convinced the board the salary committee is, in fact, an ad hoc entity, not a standing one. Therefore, its members and chair should be appointed by the board chair, not elected by trustees, as has been past

As a result of the change, Ms LeMay will select three trustees from a list of submitted names and appoint a salary committee chair in time for the next full board meeting, slated for Feb.


The teacher salary committee will be an important one in 1996 for the Halton Catholic board because the elementary and secondary school teachers' contracts expire Aug. 31.
