second, money is required to help offset testing costs.

Budget cutbacks at the Red Cross leave no money for lab work for more than 50-donors per week, according to Beth Amer. a clerk in the bone marrow department of the Hamilton chapter of the Red Cross. Ms Amer said lab work for donors beyond the 50 per week must be done by a private company at a cost of about \$50 per donor, a sum which is beyond the means of the Scholtz family if any significant number of donors is tested.

Ms Barge, a nurse at Milton District Hospital in the intensive care unit, has set up the Deidre Scholtz Fund at the Royal Bank in Milton Mall to accept donations for extra lab tests. Debbie Rennie, the bank manager of customer service, says anyone wishing to donate can simply let tellers know and their deposit will be so directed.

Deidre is unable to make any blood for herself. Without platelets her blood will not clot and without white blood cells her immune system will not defend her body from even the simplest of diseases. Each transfusion she has lessens the chances for a match to be found. She has already had two transfusions, according to Ms Barge.

Minor symptoms of the disease, such as paleness and fatigue. had been apparent for some time, said Mrs. Scholtz, but the child began to show substantial bruising the family did not suspect anything serious.

A blood test last week flagged trouble and a quick trip to the Hospital for Sick Children in Toronto last Friday confirmed the

"Even if we are unable to find a match for Deidre I want to get more people on the bone marrow registry," said Mrs. Scholtz. also a nurse at Milton District Hospital. "There were 27 children on that ward (at Sick Children's' Hospital) and they all need bone marrow as soon as possible. I don't want another mother having to hear there are not enough people on the list"

Donors are required to attend an information session to make them fully aware of the steps that lead up to a marrow donation. Those interested in joining the bone marrow registry should call the local chapter of the Red Cross at 875-1459.
