Tax payments must be received in the Corporate Services Office (formerly Treasury) on or before the due date to avoid penalty. Late payment charge of 1.1/4% will be charged on the first day of default and on the first day of each calendar month in which the default continues. It is the responsibility of the ratepayer to ensure that the taxes are paid by the due date, even in the event that the bill is not received as mailed.

Taxes may be paid:

- A) By mail to the Corporate Services Department (formerly Treasury) Box 1005, Victoria Park Square, Milton, ON L9T 4B6. Cheques post dated to the due date are acceptable.
- B) At the Canadian Imperial Bank of Commerce, Main St. Milton (there is a small service charge)
- C) By the phone if you bank with Canada Trust, TD Bank, CIBC, Royal Bank or Bank of Montreal. Please call them for details.
- D) By using the mail deposit box to the left of the glass doors at Town Hall.
- E) Between the hours of 8:30 am and 4:30 pm at the Corporate Services Office (formerly Treasury), Town Hall, Victoria Park Square, Milton. (cheque or money order is preferred rather than cash).
