"We depend on public support to help us go that extra mile and provide the quality of service that the Salvation Army is noted for," Mr. Best said.



Belford defends education budget vote

Integrity of school board under question

Concerns that votes cast on the Halton Board of Education budget were tainted by conflicts of interest have no legitimacy whatsoever, says Milton Trustee Flo Belford.

"If I don't vote then I haven't represented the people of Milton," said the trustee in an interview with The Champion yesterday.

Ms Belford, who lives with a school vice-principal, said she had every right to vote on the board's 1996-97 budget regardless of her personal relationship. Provincial law allows a person with a family member employed by a board of education to be a trustee on that board, she pointed out.

Ms Belford had reluctantly resigned from the board's salary committee in February, due to her personal relationship, and declared a conflict when the board voted on salary and benefit issues. However, she said she firmly believes that should have no bearing on her right to vote on the entire budges.

"Many trustees who declared conflicts of interbudget later voted on the entire budget," she said.

"What I'm concerned with is, is this budget going to meet the needs of the students?"

Other trustees and community groups have questioned the integrity of the board as a result of potential conflicts of interest.

"How can such a trustee squirm out from under by abstaining on a salary matter, but voting on a \$272 million budget of which 79 per cent is salary?," asked the chair of the Taxpayers stated that "... a school trustee would be precluded. Coalition Burlington's education committee,_ Frank Gue, in a letter to the newspaper.

"When the democratic process is subverted from representation of constituents into efforts - however well meant - to avoid conflicts of interest, those constituents are entitled to ask if they are represented at all."

The letter also said four Halton school board trustees have close family connections with board employees, thus casting a shadow over the legitimacy of 28 per cent of votes before the board.

Ms Belford, who said she has heard no complaints from constituents about her voting on the final budget, believes the issue has been overblown. She refused to discuss a confidential est on various items which were included in the legal opinion obtained by the board from the Ontario Public School Boards' Association, which public interest, give us a fresh start."

from discussing or voting on the proposed reduction of school board employees' salaries if the school trustee has a parent, spouse or child who is an employee affected by the budget."

The leaked document continued, 'This is especially the case where the collective agreements affected by the budget proposals are open for renegotiation ... and the relatives are covered by such 'open' agreements..."

Ms Belford's live-in companion, Ron Banyai, is a unionized board employee who would likely be affected by planned spending cutbacks.

"I won't discuss in camera matters," she said.

Mr. Gue has called for the Ms Belford's and other trustees' resignation. "The honorable thing for them to do is to leave the board and, in the
