

. Health and Safety Alert: Due to the recent news release of twenty-five or more cases of Hepatitis B infection being transmitted through a seemingly harmless medical procedure, the public must be made aware of how to protect themselves. What was once deemed safe in the past is no longer acceptable!

Simple cosmetic and natural therapeutic practices have the potential to spread infectious and deadly disease (simple parasitic and fungal infections to HIV and Hepatitis) which are not seen to the naked eve but are just as dangerous. Until Standards in Practice and Regulation are established here in Ontario, we are responsible for our own knowledgeable decisions on health and safety. Alternative health and beauty treatments have just come under regulation in Alberta with the inspection for Verifiable Sterilization in practices performing body piercing, tattooing, electrology, acupuncture etc. This is what we need here in Ontario as a start to regulating such potential infection and disease transmission Verifiable Sterilization is documented lab results or proof of sterile utensil use (sterile disposable needle use and proper discarding hazardous waste, utensils sealed and sterile, anyone touching the skin should be wearing latex gloves). *!Isopropyl Alcohol is not a sterilant and chemicals do not provide individual unopened packaging.

Think of your skin as a balloon, your greatest immunal barrier against " infection and disease. It's what we don't see (bacteria and blood-born.) pathogens) that can become harmful. Teenagers should be made aware of what to look for and the long term effect, before acquiring ear and body piercing (cartilage shrinkage) and tattooing (disposable needles and dyes) as well as other simple cosmetic trends.

Do not be fooled by unethical practices or schools, offering minimal training courses, offering a variety of services with untrained personnel, affordable pricing of service, ineffective cosmetic devices (do it yourself kits) and the list goes on

What to look for: Ask questions, seek proper Consultation and Assessment of treatment, Honesty and Responsibility for the service rendered and above all, Public Health and Safety as an educated consumer.



Chiropody (ki-rop-o-de) [Greek cheir=hand, podos=foot]

The term means to treat the foot with ones hands. The title Chiropodist, has been around since the turn of the century. It wasn't until the 1940's, in the USA, that the title Podiatrist was developed. In Canada we have both Chiropodists and Podiatrists. Chiropodists train in Canada and Podiatrists receive their training in the United States.

Chiropodists and Podiatrists are the only health care providers educated exclusively in the assessment, treatment, and diagnosis of foot disorders. We treat a wide array of foot problems includ-

- · inflammatory conditions such as heel pain, foot strain, arthritis, and athletic injuries.
- · bone deformities such as flat feet, bunions and hammer toes; ·infections
- · disorders of the skin and nails such as warts, corns, callouses, ingrown toenails, and athlete's foot.
- · symptoms of general diseases such as ulcers and joint pain · pediatric foot problems

To assess and diagnose certain conditions that require custom orthotics (arch supports), there is two casting methods I employ. I use a computerized system that produces a scan of the foot showing the pressure points and weight transfer throughout the foot or I take a non-weightbearing plaster cast of the foot.

My child's teacher said that she thinks he may have Attention Deficit Disorder. What does this mean? How can I help?

Last month we answered - What is ADD? Now for the second part How can I help? It is generally accepted that for the best results, the treatment of ADD should target all four areas covered below. That is what is meant by a MULTI-MODAL APPROACH.

1. Education and counselling Parents need help to cope with the confusion, sense of loss, guilt and anger that often accompanies ADD. Family counselling to deal with resentment is important because these children tend to be very demanding. Support groups can also be invaluable. Counselling for the child with ADD helps deal with the frustration, while developing social skills, anger management and positive self-esteem techniques.

2. School intervention helps both the teacher and the child by making sure that the school and the home are both working together with consistent rules and expectations. Often a third party is instrumental in helping with this process.

3. Behavior management at home helps in the day-to-day dealing with what can be a very difficult child. Outlining clear, concise instructions, and logical, immediate consequences (positive and/or negative), will support success. This is not bribery, it is motivation. We all do things for the results, such as pay cheque, or a clean, healthy environment.

4. Medication often offers the child the ability to concentrate and control their behaviour, which, in turn has a positive effect on every aspect of their life. Medication should always be closely monitored and adjusted as necessary. The physician's instructions must be followed closely.
