DEVELOPMENT CHARGES ACT NOTICE OF THE PASSING OF EDUCATION DEVELOPMENT CHARGES BY-LAW BY THE HALTON BOARD OF EDUCATION

TAKE NOTICE that the Halton Board of Education passed a By-Law entitled the Halton Board of Education Education Development Charges By-Law on the 23rd day of May, 1996, under section 30 of the Development Charges Act, R.S.O. 1990, c.D.9.

AND TAKE NOTICE THAT any person or organization may appeal to the Ontario Municipal Board in respect of the By-Law by filing with the Secretary of the Halton Board of Education not later than the 24th day of June, 1996, a notice of appeal setting out the objection to the By-Law and the reasons in support of the objection.

Explanation of the development charges imposed under the By-Law:

The Education Development Charges are imposed on all development of lands in the Region of Halton. Accordingly, a key map showing the location of the lands is not provided as part of this notice.

Education Development Charges shall be imposed as follows:

- effective June 3, 1996
- Residential Development - \$764.00 (per dwelling unit)
- Non-residential (Commercial) Development - 0.47% (per cent of declared construction value on non-residential permits which create new floor area)

Non-Statutory Exemptions:

- Hospitals and places of worship which are tax exempt;
- Community Colleges;
- Hydro Electric Commissions of an area municipality;
- Non-residential farm buildings;
- Private schools which are not for profit and own their own land;
- Parking structures which are ancillary to main use;
- Cemeteries which are tax exempt;
- Commercial developments with a gross floor area of 100 square feet or less.

Transitional Provision:

• Where a valid and complete application for a building permit in regard to residential or commercial development has been submitted to and accepted by an area municipality on or before June 3, 1996, education development charges shall not be imposed against such development provided the building permit in respect of which the application was made is issued on or before July 18, 1996.

TAKE NOTICE that the Halton Board of Education passed a By-Law entitled the Halton Board of Education Education Development Charges By-Law on the 23rd day of May, 1996, under section 30 of the Development Charges Act, R.S.O., 1990, c.D.9.

AND TAKE NOTICE THAT any person or organization may appeal to the Ontario Municipal Board in respect of the By-Law by filing with the Secretary of the Halton Board of Education not later than the 24th day of June, 1996, a notice of appeal setting out the objection to the By-Law and the reasons in support of the objection.

Explanation of the development charges imposed under the By-Law:

The Education Development Charges are imposed on all development of lands in the Region of Halton. Accordingly, a key map showing the location of the lands is not provided as part of this notice.

Education Development Charges shall be imposed as follows:

- effective June 3, 1996
- Residential Development - \$764.00 (per dwelling unit)
- Non-residential (Commercial) Development - 0.47% (per cent of declared construction value on non-residential permits which create new floor area)

Non-Statutory Exemptions:

- Hospitals and places of worship which are tax exempt;
- Community Colleges;
- Hydro Electric Commissions of an area municipality;
- Non-residential farm buildings;
- Private schools which are not for profit and own their own land;
- Parking structures which are ancillary to main use;
- Cemeteries which are tax exempt;
- Commercial developments with a gross floor area of 100 square feet or less.

Transitional Provision:

• Where a valid and complete application for a building permit in regard to residential or commercial development has been submitted to and accepted by an area municipality on or before June 3, 1996, education development charges shall not be imposed against such development provided the building permit in respect of which the application was made is issued on or before July 18, 1996.
