Krantz says:

Borders could be debated again

Ward boundaries in Milton and munic-

pal boundaries in Halton could soon be back on the table for debate, according to Mayor Gord Krantz.

"(Municipal Affairs Minister) Al Leach was loud and clear in encouraging municipalities to look at themselves," said Mr. Krantz. Following the recent meeting of the Association of Municipalities of Ontario (AMO) in Toronto. "Ward boundaries and the numbers of councillors in Milton could be back on the table if council wants to open it back up. I baited the hook before to see if there was merit in changes, but nobody took the bait."

According to Mr. Krantz the minister was directing his remarks on amalgamation primarily at small municipalities, in an effort to get them all to populations of at least 5,000. Currently there are more than 800 municipalities in Ontario and about 75 per cent of them have less than 5,000 people.

"It's a political decision if council wants to open up debate," said Mr. Krantz. "Changes in boundaries within Halton might make sense but there has been a hesitancy in other municipalities to open it up."

In the past Mr. Krantz has said arguments could be made that the far northern reaches of Milton, near Eden Mills, should be ceded to Wellington County, and the south western section of Halton Hills should become part of Milton. He has also mentioned the possibility of handing over a section of land along Highway 407 to Mississauga in exchange for water servicing.

"I think some people have been waiting to see what actions the province will take," said Mr. Krantz. "We will have the tools."
