# Police Blotter Lawyer wants to hurry NEC along

Says commission dragging feet on Main Street development

Some property owners would probably say the Niagara Escarpment Commission (NEC) is glacial in its deliberations, like the forces which created the landmark it protects.

Glen Schnarr, a lawyer representing landowners north of Main Street between Tremaine Read and Bronte Street, is trying to speed up the NEC.

#### Collecting endorsements

He is collecting endorsements from various levels of government and other agencies, regarding a push to remove his client's lands from the commission's jurisdiction.

Mr. Schnarr appeared at Milton town council some weeks ago and received unanimous approval of his suggestions. He went before Halton Region's planning and public works committee recently seeking the same.

Committee members, while sympathetic. deferred their consideration until all members of the committee could be brought up to speed on the

The chunk of land, of which Mr. Schnarr's clients own 160 acres or about half, is currently under the protection of the Niagara Escarpment

Plan. Land directly south of Main Street, across the road, is outside of the plan and thus could be developed, if municipal services are extended to m the area.

### Recommended for inclusion

According to Mr. Schnarr his client's land was \$ recommended for inclusion in the urban expansion area during the Halton Urban Structure Review. Much of the property is within walking distance of & the central business district of Milton.

However, according to Mr. Schnarr the NEG has been dragging its feet on making changes to the designated land.
