Bill may make some landlords pay more attention to property

To have building owners pay municipal property taxes instead of individual tenants may force some landlords out of hiding, says a downtown Milton merchant.

Steve Bonin, who owns shares in Harris Stationery but rents space from his family who own the business, said a greater onus on the landlord could bring them closer to their neighbors and issues concerning the downtown.

Bill 106, or the Fair Municipal Finance Act, addresses residential and business tax assessments, which are to be updated and standardized provincewide. The new legislation would come into effect next. January.

Part of Bill 106 calls for the scrapping of the Business Occupancy Act, the result being the takeover of tax payments by landlords.

"Maybe if they have to pay the dollars they'll be around," Mr. Bonin said. "We (tenants) pay a levy now and (if Bill 106 passes) we'll pay them (landlords) in the form of rent.

"There will always be landlords who are fair and those who demand higher rent. As long as there is demand for fair tent, those who are unfair will have to fall in line because the market will demand it."

Both landlord and tenant have valid arguments concerning the bill, Mr. Bonin said.

"Looking from my dad's point of view, he'll be imposed taxes and will raise the rent to cover it,"

explained Mr. Bonin. "The small business owner looks at big box or 'wholesale warehouses.' They don't pay a retail tax levy under the current system. Their tax rate is much lower, it's peanuts. If retailers and big boxes are going to be under equal footing (with Bill 106), then it will make a difference."

Martin Denton, who has run The Salon Group on Mary Street since 1981, said downtown Milton merchants will be hurt by the bill, since it would give landlords certain voting and representation rights on BIA boards.

"We (retailers) wouldn't have much say," remarked Mr. Denton, noting a couple of neighboring businesses are in agreement. "Taxes should be kept in the retailers' hands. I don't know where (the province) is coming from on this."

Priority is on hiring a new manager

Meanwhile, Mr. Denton's top priority these days has been working on a three-member personnel committee, interviewing prospects for the vacant general manager's position within the downtown Milton BIA.

Former manager Anthony Allwood resigned Jan. 21. His position was full-time.

Joining Mr. Denton on the committee are Ted Lindsay, ad manager of the Milton Canadian Champion newspaper and Miriam Hynek, part owner of The Dorland Haight Gallery in Milton.

"Hopefully we'll have someone in place by the end of April," reported Ms Hynek.
