Steps have been taken to ensure horse racing's future, says Snobelen

"Significant strides have been made over the past months to ensure there is horse racing in Ontario -for this year and beyond," said Snobelen. "The panel looks forward to continuing our work with the government and the horse racing industry to ensure a sustainable future for the industry."

March 31 marked the end of the Slots at Racetracks Program, a profit-sharing agreement between the government and track owners that saw 20 per cent of slot revenues fund purse pools, maintain and upgrade the facilities and enhance the sport of live racing.

The government has since renegotiated agreements with 14 tracks across the province.

In its re-released final report, the blue-ribbon panel recommends the province allocate \$179.4 million in funding over three years.

"When you consider that the industry was getting about \$345 million per year, then it looks fairly insignificant, especially given the fact that none of that money goes towards the horse people," said Brian Tropea, general manager of the Ontario Harness Horse Association (OHHA). "It looks like it's not enough money to have a sustainable industry, certainly not at the level we are accustomed in Ontario."

The panel estimates that the cost to operate racing at the premier thoroughbred level will be \$175,000 per day - or \$28 million per year. At the signature level, thoroughbred races would cost \$60,000 daily. The cost to operate events at the stan-

dardbred levels vary greatly, costing track owners \$175,000 for each premier race day, \$60,000 daily at the signature level and \$30,000 per day for grassroots races, totalling \$46.7 million annually.

However, the cost to operate racing across the province under the new Sustainable Horse Racing Model should not exceed \$78.3 million annually, stressed the panel.

While track owners were able to secure transition funding from the province, horsemen and women weren't so lucky, said Tropea. Horse people will receive revenue from pari-mutuel wagering.

With racing opportunities slashed by roughly 50 per cent, individuals are struggling to race their horses. "And when they finally do get an opportunity, they are going for way less money than they used to go for," said Tropea. "The whole indus-

try is predicated on racing opportunities and prize money. Without sufficient amounts of either of those, the industry starts to crumble, and people are seeing it now."

According to the Ministry of Agriculture and Food, the panel will work closely with industry partners, the Ministry of Finance and the Ontario Lottery and Gaming Corporation on integrating horse racing with the province's gaming strategy to offer new gaming products and generate additional revenue.

But Tropea doubts there's a product out there that will replace the \$345 million generated by the now defunct Slots at Racetracks Program.

The panel's draft plan is due in June and should be completed by October. Until then, the horse racing industry will continue to hold out for hope that the industry will prosper, said the OHHA representative.
