NOTICE OF ANNUAL MEETING OF MEMBERS PROSPERITY ONE CREDIT UNION LIMITED Wednesday, October 23rd, 2013

NOTICE IS HEREBY GIVEN that the annual meeting of the members of Prosperity One Credit Union Limited (the "Credit Union") will be held on Wednesday, October 23rd, 2013, at Granite Ridge Golf Club, 9503 Dublin Line, Milton, Ontario L9T 2X7, at 7:30 p.m. Registration begins at 6:00 p.m.

A presentation will be made to the holders of the membership shares, the Class A Shares, Series 1 and 2, and the Class D Shares, Series 1, of the Credit Union and, upon conclusion of that presentation, the membership meeting will commence.

Purpose:

The purpose of this meeting is:

- To receive the report of the Board of Directors and the Chief Executive Officer's report, the financial statements and auditors' report, and the Audit Committee's report;
- To appoint the auditor/accounting firm;
- To elect directors; and
- To transact such other business as may properly come before an annual meeting of members.

Special Business:

Special business to be conducted at this meeting is:

1. To consider and, if thought advisable, to pass, pursuant to section 309 of the Credit Unions and Caisses Populaires Act, 1994, a special resolution approving the Credit Union's proposed amalgamation with Hamilton Teachers' Credit Union Limited, carrying on business as Teachers Credit Union ("TCU"), and the carrying on of business thereafter with TCU as one amalgamated credit union, which shall be known as Tandem Financial Credit Union Limited, pursuant to the terms and conditions of an amalgamation agreement between the Credit Union and TCU dated as of the 31st day of July, 2013. Copies of the proposed special resolution are available at all offices of the Credit Union.

** Should the members and shareholders vote in favour of the amalgamation, an increase in share requirements from \$5 to \$25 will be invoked as at January 1, 2014 as per the new by-laws.

- The amalgamation is subject to approval by special resolution of the members, the holders of the Class A Shares, Series 1 and Series 2, and the holders of the Class D Shares, Series 1, of the Credit Union.
- Members of the Credit Union must be present at the meeting personally in order to have their vote counted in the members' meeting. Members of the Credit Union who are "legal persons" (i.e., corporations, partnerships, or associations) may vote by proxy as permitted by the Credit Union's by-laws.
- Only members according to the records of the Credit Union as of September 1st, 2013 (the "Record Date" according to the Credit Union's by-laws), shall be entitled to vote at the meeting.

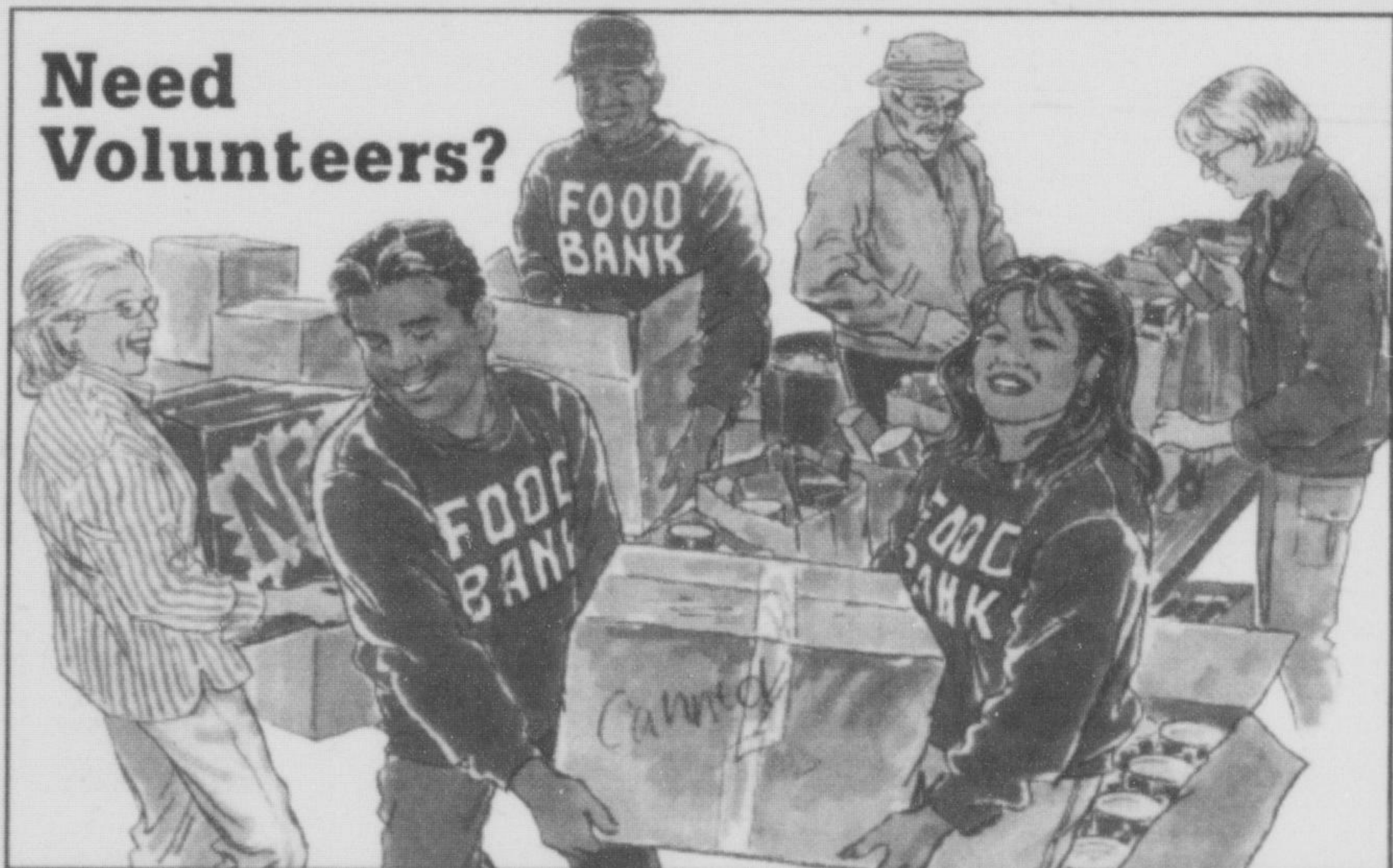
