

Public's help sought in investigation of shooting of man

weekend. Police were called to the scene after residents reported hearing gunshots, or what sounded like fireworks.

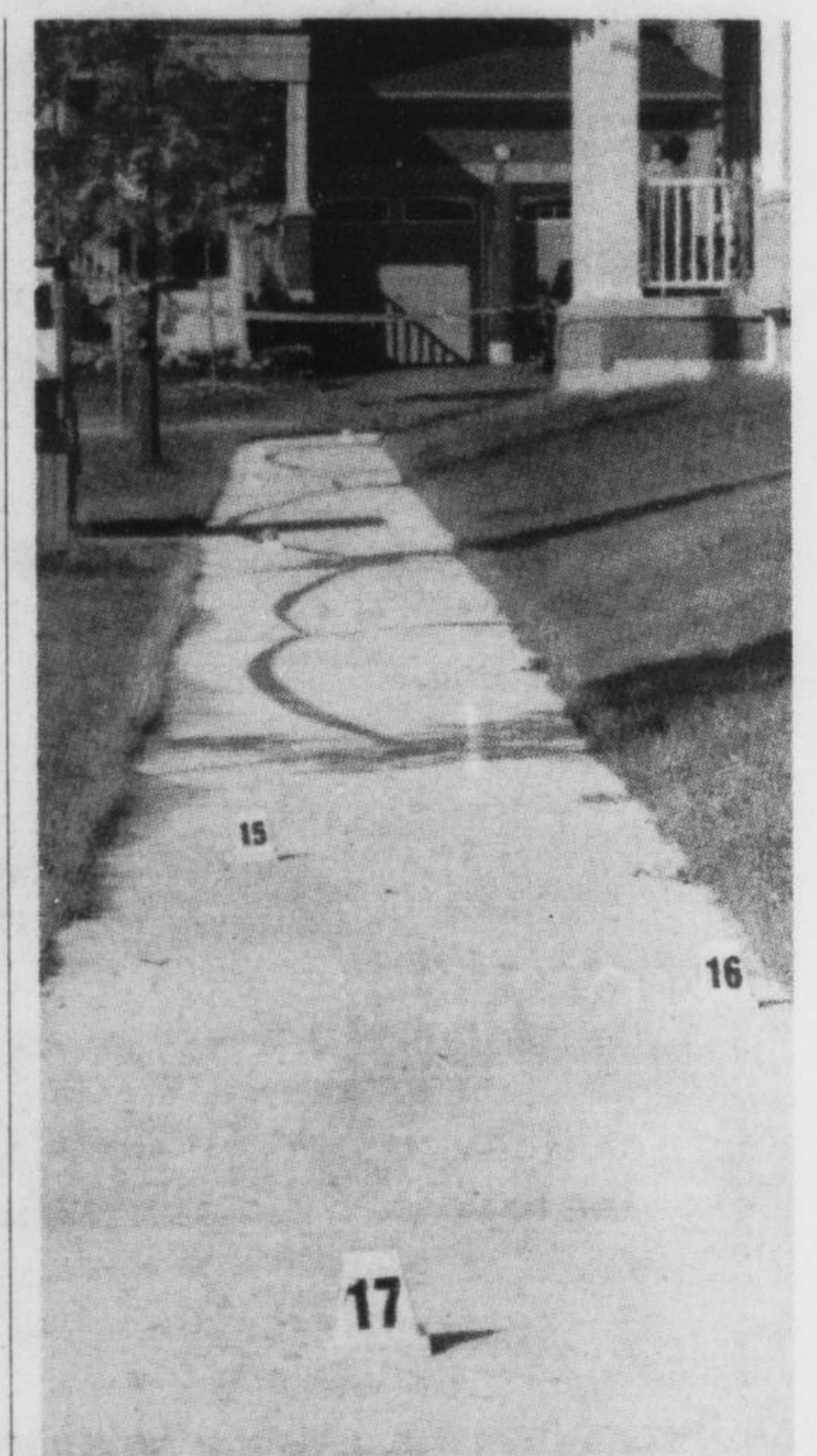
Investigators are hoping the public may have information about a four-door SUV with tinted windows seen in the area of Pringle Avenue and Wettlaufer Terrace. While Halton police continued to investigate the shooting Friday, neighbours expressed their shock. Residents on Wettlaufer Terrace near Savoline Boulevard woke up to yellow police tape and Halton police vehicles lining the streets of their generally-quiet street.

Police forensic investigators placed several yellow markers on the sidewalk where the victim collapsed. For Ross and Bonnie Shepherd, it's something they never expected from the upscale neighbourhood that features two-storey homes constructed last year.

The Milton residents, who moved in last fall, said they didn't hear the shots overnight, but woke to see several police cars and the police tape blocking the road. Investigators say the incident doesn't appear to be a random act and there's no concern for public safety.
